Report of CLD of Arkansas Presbytery for February Presbytery Meeting

Report will be given by Moderator Rev. Kade Curry

Report:

The Committee on Church Leadership Development met January 23rd 2016 via teleconference and continued its work with those under care for Church Leadership positions.

The CLD discussed guidelines for the Preparation for Ministry Process and reviewed the Arkansas Presbytery CPM Handbook. The committee also discussed at length its new responsibilities under the newly created Arkansas Presbytery structure, and looked over the new Presbytery Manual of responsibilities for the CLD committee.

The CLD reviewed its process and talked in detail about its purpose in the work of the Church at Large. There was agreement that the focus continue to be on those under care and that we personally and genuinely invest in their learning and preparation as a committee.

The CLD has approved a Covenant Agreement form that details the requirements of its Pastoral Internship that is required of its members under care.

The CLD Committee has also reviewed its documents and processes for guiding prospective Commissioned Ruling Elders to Church Leadership. The CLD has a comprehensive manual for anyone interested in CRE. The CLD encourages sessions and congregations to send prospective CRE's our way.

The CLD also has an emphasis this year on Session relations. We want all Sessions to know that we have not forgotten that the covenant agreement between those under care and the Presbytery involves the Sessions of the candidate's local church. WE want to work closely with the Sessions and home churches to ensure the best experience for those who seek to lead in the Church.

After interviewing with the Committee on CLD Katherine Norwood of 2nd Presbyterian in Little Rock requested to be enrolled as Inquirer and the committee unanimously approved this covenant agreement.

Statement of Faith- Brittany Fiscus-van Rossum

I believe in God the great creator of the universe, Father and Mother of us all. 


Administration Ministry Area

Report to the 131st Stated Meeting of the Presbytery of Arkansas February 13, 2016

In recent years the proposed budgets have reflected the expectation of *decreasing* contributions from congregations. Contributions have normally been even lower than projected. For 2015, the shortfall was nearly \$125,000. These shortfalls have required mid-year course corrections, when moderators have been asked to reign in their spending by 5% - 10%.



Reductions in expenses have not kept pace with shrinking income.



We are aware that this problem parallels the difficulties in our local congregations. We continue to be thankful to those churches that are thriving and able to support the mission work of the Presbytery.

The budget proposed for this year reflects a *decrease in total expenses of nearly 5*% from 2015. Even so, this plan forecasts a withdrawal from our investments of nearly \$134,000 in order to meet expenses (in addition to normal transfer of dividends, interest and growth).

Members of the Administration Ministry Area believe such withdrawals are unhealthy for the long-term. The alternative of trying to slash over \$134,000 from a **total budget of \$885,000** is equally problematic. In the very near future this Presbytery will need to make hard choices about priorities for mission, and to prayerfully consider the most just and compassionate way to use our financial resources.

In June 2013, the Administration Committee came to this presbytery with a proposal to give a grant of \$1,000,000 to Ferncliff Camp and Conference Center, in order for Ferncliff to apply for a matching grant. The plan was to sell a piece of property in order to raise the funds needed. Borrowing against that property in order to fulfill the commitment was accepted as a contingency. The promise to Presbytery at that time was that the transaction would be *Cash Neutral*: financial support normally given to Ferncliff would be used to pay interest on a loan (if necessary).

We are working to keep that promise, but face some unexpected problems.

- The property has not sold. There has not even been an offer.
- The property was appraised for 1/3 of the value we were expecting.
- We have been paying interest only for 12 months, with the option of continuing to do so for 12 more months. The debt has not been reduced.
- We find ourselves making payments on debts we did not expect to have, with shrinking income.

These are the options we have considered (and prayed over) to best address this gaping hole in the budget.

- Our current plan is to continue paying interest only, while exploring options to pay off the unsecured loan by January, 2017. Those options include using other assets (property and/or investments) to pay down the debt.
- Support for Ferncliff Camp and Conference Center was reduced for this year by 10%, which is the amount that other ministry areas were asked to cut from their budgets.
- Support for Ferncliff in 2017 will be adjusted, based on payments needed for the two loans.

There are problems for the long term with each of these plans, for the presbytery and for Ferncliff.

Motion for Presbytery:

- Approve the current plan for paying interest only on debt.
- Adopt the proposed budget.


