The Committee on Ministry sustained the examination of RE Michelle Hall of First Presbyterian Church of Lincoln by the Northwest Arkansas Examinations Subcommittee and approved the covenant between RE Hall and First Presbyterian Church of Lincoln and the covenant between RE Hall and First Presbyterian Church of Prairie Grove, both effective June 1, 2021 through December 31, 2021. The covenants will be reviewed after three months of the contract/covenant and prior to the end of the year by the CRE, the sessions of each respective congregation, and representatives of the Committee on Ministry, with the option of extending the relationship. The commissioning comes with the authority to moderate the session and to administer the sacraments. MWS Kade Curry has been assigned as the mentor and supervisor for CRE Michelle Hall, as per G-2.1004 of the *Book of Order*.
