PRESBYTERY RECONVENES

The Presbytery reconvened at 8:30 a.m. on Saturday, February 21 in the Rogers Conference Center, University of the Ozarks with Morning Worship led by the Youth of the Presbytery, which included the installation of the Vice Moderator TE Lacy Sellars.

GENERAL COMMITTEE REPORT CONTINUED

TE Clare Kelley, Moderator of the General Committee completed their report: In response to a request from the Committee on Administration and General Presbyter Bill Galbraith,

- 1. The General Committee moves to extend Bill Galbraith's terms of call as recommended by Administration through June 30, 2015. PASSED.
- General Committee moves that after June 30, 2015, Bill Galbraith continue on a month-tomonth basis as General Presbyter until a new General Presbyter can be called or until the end of 2015, whichever comes first. PASSED.
- 3. Upon receipt of Stated Clerk Cathy Ulrich's letter of resignation, General Committee moves Presbytery to suspend Section 4.3D of the Standing Rules ("If the stated clerk resigns or is unable to serve during the three-year term, the General Committee of the presbytery shall immediately contact previous stated clerks within the presbytery and ascertain the willingness and availability of any of these persons to serve immediately as acting stated clerk."), allowing Presbytery to elect an acting stated clerk to serve until June 6, when Nominations Committee must have completed the search for a Stated Clerk, and General Committee nominates Teaching Elder David Dyer, current Assistant Stated Clerk, to serve as acting stated clerk. (This motion requires a 2/3 vote for passage, and if passed will not be revoked by the Presbytery's subsequent vote on any of the Restructure Task Force motions in this meeting's agenda.) PASSED.
- 4. General Committee reports that if the above motion is passed, it has approved that while TE David Dyer is serving as acting stated clerk he would be paid as Stated Clerk and RE NiAnn Thompson would be paid as his administrative assistant.

COMMITTEE ON ADMINISTRATION

- TE Catherine Allsbury, Moderator, presented the report of the Committee on Administration. The following items were included:
- 1. Proposed change in terms of call for General Presbyter.
- a. Motion for Presbytery: That the terms of call for the General Presbyter (William F. Galbraith) be extended from 2/21/15 to 6/30/15. PASSED
- 2. Loans from Bancorpsouth
- a. Loan for \$747,500 secured by the Chenal Property;

This will mean lowering the budget for the Christian Education Committee in 2016 by the amount diverted to loan payments.

We ask the Governor to use his power to veto this legislation. **PASSED** and the Acting Stated Clerk was instructed to communicate the action to Governor Asa Hutchinson.
