

### Approved Minutes of the One Hundred Fifty-Second Stated Meeting of The Presbytery of Arkansas

### March 3-4, 2023

# Friday, March 3, 2023

The 152<sup>nd</sup> Stated Meeting of the Presbytery of Arkansas and was hosted by Lyon College in Batesville. The in-person meeting also was comprised of a livestreaming component via Zoom on Friday and a Zoom component Saturday. A procession led by two members of the Lyon College Pipe Band opened the meeting as the leadership took the stage.

## **Call to Order and Opening Prayer**

The 152<sup>nd</sup> Stated Meeting of the Presbytery of Arkansas was called to order by the gavel tapping, lighting of the Christ candle, by Moderator MWS Susan Arnold who also made the opening prayer in Brown Chapel at Lyon College at 6:36 pm on March 3, 2023.

### **Introductions and Welcome**

Moderator Arnold welcomed all the attendees and introduced the General Presbyter, MWS Stewart Smith. He welcomed all of the attendees including corresponding members, first-time commissioners, and the Zoom participants who were monitored by Westin, a student from Lyon College. He had the first time commissioners stand for acknowledgement: RE Dawn Cattaneo, Hot Springs, First; RE Bracy Cross, Little Rock, Second; RE Kathy Evans, Pea Ridge, Mount Vernon; RE Lisa Holloway, Heber Springs, First; RE Becky Lewis, Little Rock, Pulaski Heights;

RE Marcia Szabo, Searcy, First; and RE Joseph Yancy, Little Rock, Second. On Zoom was RE Susan Bradshaw, Conway, First. Also a first time attendee was Rev. Jami Scott.

Smith introduced the presbytery staff, starting with the presbytery's stated clerk, MWS Blake Brinegar, who is also the pastor at First Searcy. He introduced the presbytery builder, MWS Carol Clark; Kim Palmer, the administrator at the presbytery and the presbytery connector, Julie Price, who was manning the registration desk assisting late arrivals. MWS Brianne Christiansen, Youth Interim Director, was on Zoom from Montana.

Moderator Arnold called on Stated Clerk Brinegar who described the hybrid meeting with electronic participation. He said that folks could watch the livestream on Zoom with no participation Friday night and participate in Zoom on Saturday with the ability to ask questions and vote.

Moderator Arnold asked for four volunteers to be a teller during the meeting and she announced that the appointed tellers were: CRE David Clark, Heber Springs, First; RE Kim Danehower, Forrest City, Graham Memorial; RE Alice Kutz, Springdale, First; and MWS Bill Seitz, Mena, First.

Moderator Arnold welcomed Dr. Melissa Taverner, the president of Lyon College in Batesville who welcomed the attendees to Batesville and to the college. She described the college's expansion with online instruction and the addition of a master's program in teaching. She also discussed the irony of the last time the presbytery met at Lyon College, Covid shut everything down for two years right after.

### **General Presbyter's Report**

Moderator Arnold asked for the General Presbyter's report. General Presbyter Smith reported that the presbytery office was flooded by a frozen pipe that thawed after Christmas and there is no update as we still are waiting on the authorization from the insurance company for payment of the mitigation, storage, build back and the move back in cost. He wanted to preface the budget discussion by saying that it's been steady for a number of years and now starting to see this year an evidence of decline in giving from congregations. The proposed budget has an amount for contributions that is lower than it was in 2022 but expects a minimal impact on budgets for the committees. He stated he continues to be grateful for the congregation's faithful support. He also discussed the flyer in the addendum packet for the upcoming Rural Leadership Education retreat at the College of the Ozarks on May 19-21, 2023. The university is paying all of the expenses associated with the gathering, including meals and lodging. The meeting took a few minutes break before the worship service began.

### Worship

A copy of the worship bulletin may be found in the Appendix, Section II. Worship began at 7 p.m. with a prelude by organist Kristian Ameigh in Brown Chapel. The Lyon College Gospel Choir performed, "*Every Day is a Day of Thanksgiving*." MWS Susan Arnold led the sermon, "Going Over," with scripture from Acts 16:9-15.

Outgoing moderator Susan Arnold led the installation of the new moderator, Mike Szabo, ruling elder at First Presbyterian Church of Searcy, with the charge by MWS Carol Clark, who charged him with the words, "You be you." General Presbyter Stewart Smith thanked outgoing moderator, MWS Susan Arnold, and presented her with a small token from the presbytery. MWS Blake Brinegar gave the charge to the presbytery for the coming year.

As of March 13, 2023, \$966.00 has been collected to benefit the Presbytery of Arkansas Scholarship at Lyon College. The Sacrament of the Lord's Supper was led by MWS Elizabeth Brinegar, transition pastor at Batesville, First and MWS Maggie Alsup, chaplain at Lyon College.

The Christ Candle was extinguished and the meeting was adjourned until 8:30 a.m. Saturday morning.

## Saturday, March 4, 2023

### Call Back to Order with the Lighting of the Christ Candle

The 152<sup>nd</sup> Stated Meeting of the Presbytery of Arkansas continued Saturday morning with Moderator RE Mike Szabo reconvening the 152<sup>nd</sup> Meeting of the Presbytery of Arkansas back to order at 8:35 am with the lighting of the Christ candle and he opened the meeting with prayer in Edwards Commons on the campus of Lyon College. Stated Clerk Blake Brinegar confirmed that the four tellers were present at the meeting.

### **Consent Agenda and Declaration of a Quorum**

Moderator Szabo moved to the Consent Agenda presented by Stated Clerk Brinegar who explained that all motions may be voted on as one and anyone is welcome to remove any item for discussion. Moderator Szabo asked if anyone wanted an item removed. A request was made to remove amendment 22D from the consent agenda for discussion. Moderator Szabo entertained a motion, one was made and seconded. The motion passed unanimously. The consent agenda may be found in the Appendix, Section III. The amendment 22D was added to the amendment discussion to be held later in the meeting.

A quorum for the stated meeting is at least 20 Ruling Elders and 20 Ministers of the Word and Sacrament with at least 20 congregations represented overall, as approved at the February 10, 2018 Stated Meeting. A quorum was present with a total of 133 registered, of whom 106 could vote. The attendance is included in the Appendix, Section I.

### **Stated Clerk's Report**

Stated Clerk Blake Brinegar stated, "I have received allegations against a member of the presbytery. An investigative committee has been formed to investigate the allegations. The committee is comprised of: MSW Brian Brock, Russellville, First; MWS Leslie Roper, Hot Springs, First; RE Geoff Ryken, Conway, First; RE Sarah Keith-Bolden, Little Rock, First." The

written informational portion of the Stated Clerk's Report may be found in the Appendix, Section IV. The meeting then moved into worship.

### Sermon by Rev. Michael Gallup

Rev. Michael Gallup has requested to transfer his ordination from the Evangelical Presbyterian Church to the Presbyterian Church (USA). He preached from a series of scriptures including Jeremiah 9:19, Psalm 13 and Psalm 88 entitling his sermon, "Gift of Grief, and Lament."

### **Business of the Presbytery**

### **Committee on Ministry Report**

Moderator Szabo called on MWS Stewart Smith, acting moderator, to give the report for the Committee on Ministry. Smith referred attendees to the addendum packet for the first motion which does not need a second since it came from a committee.

1. Motion to examine Rev. Michael Gallup in order to transfer his ordination from the Evangelical Presbyterian Church to the Presbyterian Church (USA) and to enroll him as a member of the Presbytery of Arkansas. Michael's Statement of Faith is included in the Appendix, Section V.

Questions were asked in areas of faith, preaching, Bible, theology, polity, worship, and sacraments which were all answered, and this part of the exam was sustained, with no dissenting votes. Rev. Gallup was taken to a waiting room at 9:43 am while the presbytery further deliberated on his transfer. A motion was made for the presbytery to waive the PC(USA) exams. The motion was seconded and Stated Clerk Brinegar read G-2.0505(2), which states a minister of another Reformed church, ordained five years or more can be granted an exemption of some or all examinations required of candidates for ordination by a 2/3 vote of the presbytery. A vote was held, the motion was approved with no dissent. A motion was made to enroll Gallup as a member of the Presbytery of Arkansas. The vote was all affirmative and the motion carried with a 2/3 majority. He was invited back to the meeting and was welcomed into the presbytery with clapping and enrolled as a member of the Presbytery of Arkansas.

# 2. Motion to enroll Rev. Jami Scott as a temporary member of the Presbytery of Arkansas.

Rev. Jami Scott is serving in a temporary pastoral relationship at The Presbyterian Church of Bull Shoals. Jami has passed all of the requirements of the Presbytery of Arkansas and the Committee on Ministry for temporary membership in the presbytery. No second was needed since the motion came from a committee, motion was unanimously approved. Jami introduced herself to the presbytery.

# **3.** Motion to approve and enroll Rev. Dr. Randy Hyde as a Temporary Member of the Presbytery of Arkansas:

Rev. Randy Hyde, serving in a temporary pastoral relationship at Second Presbyterian Church of Little Rock. Rev. Hyde is a member in good standing of the Cooperative Baptist Fellowship and served previously in a temporary pastoral relationship at Second Presbyterian Church as a transitional Associate Pastor. Randy has passed all of the requirements of the Presbytery of Arkansas and the Committee on Ministry for temporary membership in our presbytery. No second was needed since the motion came from a committee, motion was unanimously approved.

# 4. Motion to grant honorable retirement to MWS Paul Fulks effective November 1, 2022.

Motion was unanimously approved.

### Necrology

MWS Stewart Smith asked the presbytery to observe a moment of silence to reflect on the life and ministry of MWS Bob Hyatt whose work on this earth has ended, and who has received his reward and is at home with God and all the saints in the Kingdom of God. His obituary may be found within the written report for the Committee on Ministry in the Appendix, Section V.

### **Ferncliff Report**

Moderator Szabo called on Joel Gill, Director at Ferncliff and MWS Jocelyn Wildwright, for their report on Ferncliff. They played an interactive online game called Kahoot! with the audience that updated everyone on how Ferncliff is doing and what is going on. He also mentioned the table in the hallway with more information about Ferncliff.

### Wellspring Covenant

MWS Rebecca Spooner, who has been ordained for 30 years, explained the covenant Wellspring Renewal Center has with the presbytery for counseling services. She shared new additions to the contract which offers coaching opportunities in addition to the counseling services offered at no cost to pastors (and their families) who are serving in congregations. She asked for questions and there were none. A copy of the covenant may be found in the Appendix, Section VI

The meeting took a break for 15 minutes. The meeting was reconvened at 10:37 and Zoom participants were instructed on the voting process. The technology at Lyon College differed from the Zoom account the presbytery uses so voting was different than members were used to. To vote yes, the participants voted yes with a thumbs up. The votes would be tallied and cleared, then to vote no, the participants also had to vote thumbs up for a no vote. Those would also be tallied and cleared and cleared and all counts would be reported to the moderator.

### **Committee on Preparation for Ministry Report**

Moderator Mike Szabo recognized MWS Elizabeth Brinegar, moderator of the Committee on Preparation for Ministry to give a report. She said that there are two ruling elders that are ready to take the CRE exam and there is a new person who has just enrolled in the CRE program.

# 1. Motion to request that the presbytery allow us to remove David Mills from the inquirer rolls at this time.

The moderator asked for a vote after the motion was made, all voted in favor, the motion passed.

#### 2. We request that the presbytery adopt the following resolution:

"As the Presbytery of Arkansas, we acknowledge that it is our responsibility to provide pastoral care and support for all inquirers and candidates under our care. We stand with Jesus Christ beside those who have been and are oppressed, marginalized, and traumatized. We therefore call on the Presbyteries' Cooperative Committee on Examinations for Candidates (PCC) to refrain from using texts of terror (those which dehumanize, justify violence, perpetuate oppression, and which have been weaponized against God's children) in future exams."

The committee proposed the resolution and explained the rationale was in the main packet on page 15 which was related to the selection of Judges 19 for the PC(USA)'s recent ordination exeges is exam. A discussion was held and the resolution failed to be approved. A copy of the written report and rationale may be found in the Appendix, Section VII.

### **Committee on Administration Report**

Moderator Szabo recognized RE Carolyn Willis, moderator of the Committee on Administration for her report. She led a discussion on the proposed 2023 budget, the staff was asked to leave the meeting. Upon the staff's return, it was announced that the proposed budget was approved which included a 4% cost of living increase for the presbytery staff of a year or more. The general presbyter's Terms of Call were also approved. A copy of the written report which includes the proposed budget, financial information, and the treasurer's report may be found in the Appendix, Section VIII.

### **Youth A-Team Report**

Sadie Buck, youth moderator, reported to the presbytery that the youth has been able to reconnect this year. She showed a slide show of Mission Possible, YouthQuake and thanked everyone for their support. She also mentioned that the youth are selling t-shirts and sweatshirts that will support this summer's trip to Montreat. She also announced two General Assembly amendments the youth suggested to approve, 22P and 22I.

Brianne Christiansen, interim director of youth, thanked the presbytery via Zoom for welcoming the youth at this meeting. Announced next Mission Possible will be held in Russellville on April 14 and the deadline for summer trips was March 15. Montreat will be held July 9-July 15. The junior high will have Presbytery Week at Ferncliff June 18-23. The written report may be found in the Appendix, Section IX.

### Announcements

Jeremy Wilhelmi announced that he is retiring from University of the Ozarks and this is his last presbytery meeting, his work is done at the university and wanted to connect the presbytery with Dawn Dvoracek.

Mike Qualls announced that Graham Memorial in Forrest City will celebrate their 150<sup>th</sup> anniversary on June 11 with Stewart Smith in the pulpit and invited everyone to attend.

Presbytery Pilgrimage is April 13-16, a lay led mission supported event. A flyer is in the main packet to apply.

Carolyn Willis announced that the Presbytery Women Spring Gathering will be held at Ferncliff on April 22.

Robert Lowry announced the Muses free spring concert on March 13 at 7 pm and noon on Wednesdays he has a Bible study, email the church office at mailto:office.westoverhills@gmail.com for more information.

Stewart Smith offered the blessing for the meal and the meeting was adjourned for lunch.

### **Future of the Church Committee Report**

After lunch, Moderator Szabo called RE Cindy Lanphear, moderator of the Future of the Church Committee to give the committee report. She reported that the grant season is open until April 15 and encouraged churches to apply. She offered thanks for the committee and the table that had book giveaways, information and a guess the number of pompoms for a book study giveaway. Becky Lewis from Pulaski Heights in Little Rock was the winner for her guess of 150 and the number of pompoms was 152, a nod to the 152<sup>nd</sup> meeting being held. A copy of the written report may be found in the Appendix, Section X.

### **Mission of the Church Committee Report**

Moderator Szabo called on CRE Peg Falls-Corbett, moderator of the Mission of the Church, to give the committee's report. She said that Christian education is part of the committee's budget and Mission Initiative Grants are available now and applications are due by April 15. If funds are left over, more grants would be available July 15 and October 15. The written report may be found in the Appendix, Section XI.

### **Report of the Polity Committee**

The 225th General Assembly (2022) of the Presbyterian Church (USA) approved and recommended to the presbyteries, for their affirmative or negative votes, proposed changes in the language of the Book of Order that, if approved, will amend the Constitution. Stated Clerk Blake Brinegar reported on the findings of the polity committee regarding the amendments. A copy of the written policy committee report may be found in the Appendix, Section XII. Amendments in the consent agenda that were approved are:

Moderator Szabo called on MWS Rebecca Spooner, to offer the closing prayer. He extinguished the Christ candle, tapped the gavel and adjourned the meeting at 2:46 p.m. He thanked everyone for showing up and doing the work of the presbytery.

### Worship Leadership

### **Necrology** In Memoriam – Rev. Bob Hyatt October 17, 1931 – February 12, 2023

Robert Lee Hyatt (Bob), 91, honorably retired member of the Presbytery of Arkansas, died Sunday, February 12, 2023 in Fort Smith.

He was born October 17, 1931, in Monticello, Ark. He was a 1949 graduate of Hope High School. Bob attended Arkansas College and graduated from Austin College in Sherman, Texas, in 1953. He earned his M.A. in Education in 1956 at the University of Arkansas. In 1957 he graduated with a Bachelor of Divinity degree from Union Theological Seminary in Richmond, Va. That same year he began his career as a Presbyterian minister with his first church in Augusta, Ark., commencing his 60 plus years of service as a pastor in Arkansas, Tennessee, Texas, and Louisiana.

Bob married Patricia Susan Bass of North Little Rock, Ark., in December of 1962. He and Pat were married for 47 years. Wherever they lived, they enjoyed meeting new people and immersing themselves into the different cultures, from the dry plains of western Texas to the swamps of southern Louisiana. With maybe a glass of wine in hand, they loved to relax on their back porch in the evening and talk about the day's events.

Bob was an avid nature lover, birdwatcher, Razorback fan, and loved classical music, especially the organ. He was a champion of the underdog both in sports and life in general. He enjoyed vacationing at the gulf coast with his family and friends. He admired the power and awe of a West Texas thunderstorm, as well as the gentle rains of the Smoky Mountains. He thought education was of utmost importance, and he was a model for humility and gentleness.

He is preceded in death by his wife Pat, brother Dr. Ben Hyatt from Perryville, Ark., and sister Effie Frazier from Hope, Ark.

He is survived by brother Charles Hyatt of Tupelo, Miss. (wife Joy), son Martin Hyatt of Fort Smith, Ark., (wife Jacinda), son Tommy Hyatt of Rowlett, Texas (wife Melissa), and five grandchildren.

Counseling services at Wellspring Renewal Center are provided by Rev. Rebecca Spooner LPC, PLLC, and other therapists on Wellspring's Clergy Counseling Network. All counselors providing service are licensed by the state board and are bound by the legal and ethical statutes of their profession. They also carry their own professional liability insurance. The Presbytery of Arkansas is not liable for any actions of Wellspring or of Rev. Rebecca Spooner LPC, PLLC, or any therapists in the Counseling Network. All counseling records of Wellspring are confidential and information will only be released to the Presbytery with written consent from the client. Wellspring Renewal Center or any counselor on the Network does not provide letters of reference for Ministers, Commissioned Ruling Elders, Certified Christian Educators or any of its clients.

Counselors may refer clients to another therapist if there is a conflict of interest on behalf of the client or the counselor, or when the counselor believes it to be therapeutically necessary. The Presbytery of Arkansas, nor its Committee on the Church and Its Ministries shall in any way control either Wellspring Renewal Center, Reverend Spooner or Network counselors as they carry out the terms of this agreement. Wellspring Renewal Center and Reverend Spooner are responsible for the performance of the work pursuant to this contract and the selection of the methods used to accomplish the terms of this contract. The Presbytery of Arkansas and its Committee on the Church and Its Ministries are only concerned with the results. The Presbytery of Arkansas has no jurisdiction over the actions of Wellspring Renewal Center and therefore is not responsible for its methods or outcomes. Rev. Spooner will report to the Committee on the Church and Its Ministries annually and at the request of the committee's moderator.

If the Presbytery or its Committee on the Church and Its Ministries is dissatisfied with the performance of Wellspring Renewal Center or any Network Counselors, formal complaints may be made to the State Board of Examiners in Counseling (101 East Capital Ave. #202, Little Rock, AR 72201). ## **Report of the Committee on Preparation for Ministry**

MWS Elizabeth Brinegar Moderator

For Information:

At our meeting on February 18, 2023:

1. We voted HR Susan Grey as Vice-Moderator and RE Kim Danehower as Secretary.

2. We formed a subcommittee to review and grade Commissioned Ruling Elder (CRE) final exams. This subcommittee is made up of RE Ronnie Provost, MWS Katie Cummings, and MWS Matt Bussell.

3. RE Kim Danehower (Graham Memorial, Forrest City), having successfully completed all requirements, is allowed to sit for the CRE examination.

4. RE Mary Jane Fischer (First, Jacksonville), having successfully completed all requirements, is allowed to sit for the CRE examination.

5. RE Janet Benson (Graham Memorial, Forrest City) has been accepted into the CRE program through the Presbytery of Arkansas.

6. The current CRE program requires a report on the book, *Healthy Congregations, A Systems Approach,* by Stephen L. Steinke. It was requested that the committee consider different options from the book as it can be argued how we view a healthy congregation has changed since the COVID pandemic. The committee agreed to take the request under consideration and bring back different options to the next meeting.

### Section VII – Exhibit I

#### **Rationale for Resolution from the Committee on Preparation for Ministry**

Warning: This report contains references to sexual assault, violence and abuse, and could be triggering for survivors and their loved ones.

#### **The Ordination Process**

The PC(USA) takes ordination of ministers of Word and Sacrament very seriously and therefore has an established process to ensure that aspiring ministers are prepared for their calling. The process requires at least two years and has two phases: inquiry and candidacy. This process involves mutual discernment between the individual pursuing ordination and the presbytery acting through the Committee on Preparation for Ministry. According to G-2.0607, "A candidate may not enter into negotiation for his or her service as a minister of the Word and Sacrament without approval of the presbytery of care." Evidence for readiness to begin ministry of Word and Sacrament includes: graduation from college or university, graduation from an accredited theological institution with coursework done in Greek and Hebrew, and "examination materials, together with evaluations that declare those materials satisfactory in the areas covered by any standard ordination examination approved by the General Assembly. Such examinations shall be prepared and administered by a body created by the presbyteries" (G-2.0607d).

#### **The Ordination Exams**

There are five ordination exams: Bible Content, Biblical Exegesis, Theological Competence, Worship and Sacraments, and Church Polity. The Biblical Exegesis, Theological Competence, Worship and Sacraments, and Church Polity exams may be taken only with the permission of the presbytery's Committee on Preparation for Ministry. These exams are designed to be taken near the end of a candidate's preparation as an assessment of readiness to begin ministry and are offered three times a year.

The ordination exams are written by the Presbyteries' Cooperative Committee on Examination for Candidates (PCC). The PCC meets annually and has twenty-four members. Twelve members of the Committee are elected (on a rotating basis) from among readers in six regional groupings of presbyteries. The other twelve members are elected by the General Assembly. Committee members serve a four-year term. The PCC has a three-year process of developing the specific questions and the evaluation resources prepared for the readers.

#### January 2023 Exegesis Exam

The Biblical Exegesis exam in January 2023 dealt with a passage from Judges 19 entitled "The Levite's Concubine." In this story, a man offers his daughter to angry mob to be raped by them to appease their anger. After a night of horror, the woman is unconscious and is taken away to be brutally murdered and dismembered.

When it became known that Judges 19 was the text for the Biblical Exegesis exam there was widespread condemnation on social media. It is a text of terror which dehumanizes women and justifies violence, particularly sexual violence, against them. For those who have experienced sexual assault,

violence, or abuse, this text would re-traumatize survivors. According to the Center for Disease Control, "Over half of women and almost 1 in 3 men have experienced sexual violence involving physical contact during their lifetimes. One in 4 women and about 1 in 26 men have experienced completed or attempted rape."

We recognize that the Bible has many texts of terror which are necessary for Ministers of Word and Sacrament to wrestle with in their ministry. However, unlike in ordination exams which are done alone, ministry is by its very nature communal. It is our hope that candidates and inquirers are equipped with the necessary tools to properly exegete Biblical passages and that they develop communities which support them and wrestle with these texts with them. Addressing texts of terror is important in ministry, but it is not necessary for inquirers and candidates to be examined on these passages as part of the ordination process.

#### Do No Harm

The resolution from the Committee on Preparation for Ministry acknowledges our responsibility not only as a committee but also as the entire presbytery to care for those enrolled as inquirers and candidates and calls for the Presbyteries' Cooperative Committee on Examinations for Candidates (PCC) to refrain from using texts of terror in future exams. In short, we are asking the PCC to do no harm to the exam takers. This resolution is an attempt to learn from the experience of the January 2023 exegesis exam as we look forward to how we can support inquirers and candidates as they navigate the ordination process.

### Report of the Treasurer Calendar Year 2022 RE Tom Verdery

#### **For Information**

- 1. The Presbytery of Arkansas calendar year 2022 income came in slightly above budget due to our Texas Presbyterian Foundation (TPF) investment income (spend rate) ahead of projections based upon a 36-month rolling average (+\$16,732). Expenses for 2022 were below budget, mainly due to gaps in two staff positions during the year (Stated Clerk and reduced responsibilities in the Youth & Young Adult position) and reduced spending with several committees/ministries based upon concerns over Covid in the first half of the year (+73,817). We continue to be grateful for all Church Benevolence contributions to the Presbytery of Arkansas.
- 2. 2022 was a challenging year in the financial markets, including Texas Presbyterian Foundation performance in their Balanced Pooled Funds down 17.5%. Fortunately, your Presbytery of Arkansas is in a strong cash flow position with significant funds in money market and checking accounts, eliminating the need to take significant withdrawals from the Balanced Pooled funds invested in stocks and fixed income this year.
- 3. We completed our 2021 Independent Financial Review from Benchmarks Accounting Firm. The accounting firm's review came back with a solid review showing no discrepancies or recommendations for modification of any of our financial statements.
- 4. Your Committee on Administration will be bringing their proposed 2023 financial budget for your review and approval. Documents related to the budget are located in the addendum packet.
- 5. Our continued focus for 2023 and beyond will be creating programs and support to help all churches as they move back to normal activities post pandemic.

#### **Section XIII**

#### Coordinating Team Report March 4, 2023

The Coordinating Team met on January 17 and approved a time sensitive request from Central Presbyterian Church in Russellville to sell a small portion of their property for easement/right-of-way to the City of Russellville for utility upgrades/sidewalk improvement/landscaping, etc. The amount totals \$41,623.40. (See attachment, Section J Exhibit I)

The Coordinating Team met for a regularly scheduled meeting on February 3, 2023 and took the following actions:

The Coordinating Team set the date of October 6-7,2023 for the 154<sup>th</sup> Stated Presbytery of Arkansas Meeting at First Presbyterian, Jonesboro. The remaining meeting dates for 2023 are: June 3, 2023 via Zoom; and October 6-7, 2023 at First Presbyterian Church of Jonesboro.

Fulfilling a request from the Synod of the Sun Coordinating Team, the names of Elizabeth Brinegar and Steve Hancock were approved for consideration for the Synod Leader Search Committee. (Note: Elizabeth Brinegar was selected to serve as the representative from the Presbytery of Arkansas).

The Coordinating Team approved a request from First Presbyterian Church in Jonesboro to extend their current loan with Presbyterian Investment and Loan Program (PILP) by five years. The loan modification will result in lower monthly payments that can be absorbed in the church's annual operating budget. The remaining balance as of 12-13-22 was 74,858.94. The loan modification was approved by PILP. (See attachment, Section J Exhibit II)

A discussion was held regarding the youth position and a motion was made and approved to grant General Presbyter Stewart Smith: 1. Permission to form the exploratory committee; 2. Permission for the exploratory committee to amend the job description; 3. Permission for the exploratory committee to populate the search committee.

Three names were suggested for the Presbytery's Nominating Committee for a three year term, Class of 2025. They will be asked if they want to serve. The moderator of the committee will be chosen after members are appointed.

A discussion was held regarding a speaker for the October meeting. A decision was postponed to a March meeting of the Coordinating Team.

**Church Request:** Per email from church treasurer: First Presbyterian Church in Jonesboro, AR would like to extend the maturity of our loan from the Presbyterian Investment Loan Program by 5 years. We've been paying more than the required payments for the past several years from funds we raised in our 2012 Capital Campaign, \$13,000 of these funds remain. At the current payment level, these funds will run out mid-2023 and we'll have to add the note payments to our annual budget (or have a new capital campaign). We'd like to reduce the payment (and resulting budget impact) going forward. Our church has begun Project Regeneration with Presbyterian Foundation to help us set a long-term direction for the church. Pledges are up in 2023 and the Session approved a balanced budget for 2023 (assuming we complete this refinancing and can use the remaining Capital Campaign funds to fund 2023 payments).

The Fixed Asset amounts on the balance sheet are not cost based and pre-date my role as Treasurer. My understanding is that this was an estimate of FMV at some point in the past. We have not had an appraisal of the church property, so I don't know how realistic those amounts are. The income statements shown are for the operations of the church. We have a pre-school that operates under the church, and it has separate income statements (on a school year basis). Together, the church and pre-school received \$74,000 in PPP loans in 2020 and these were forgiven in 2021.

Recommendation: It is recommended the loan term be extended by five years and re-amortized to reduce the monthly payments.

## WHAT IS PRESBYTERIAN PILGRIMAGE?

**Presbyterian Pilgrimage** is an intentionally designed faith renewal program for individuals. Its goal is to have a positive spiritual impact on the individual and, thus, on the environments in which they live and work. **"Pilgrimage"** is a short course in living the Christian faith. It is designed for Christians, to strengthen their faith, and to provide them with a framework for continued spiritual growth within their church and in the world.

## HOW DOES IT ACCOMPLISH ITS AIMS?

During the three days of a *Presbyterian Pilgrimage* Weekend, participants form small Christian communities. In worship, study, discussion, and singing, they gain a personal, awareness of their faith and relationship with Jesus Christ. Through this awareness, the joys and responsibilities of that faith are recognized. Talks presented by laity and clergy provide a central focus for the Weekend activities.



#### WHO GOES TO PRESBYTERIAN PILGRIMAGE?

The Weekend is not designed as a conversion experience. Its focus is on those who are seeking continued growth in their faith and its application to their daily lives. It is the goal of *Presbyterian Pilgrimage* to provide participants with the opportunity to experience an even closer and more personal relationship with Christ, to deepen their faith, and to invigorate their life in Christ. Participants return to their environments and affect them in a Christian manner. Single and married individuals are welcome, and men and women attend the same Weekends. The staff is led by laity and Presbyterian clergy who have previously attended a 3-Day Weekend.

#### HOW CAN I ATTEND PRESBYTERIAN PILGRIMAGE?

Fill out the application on the reverse side and send it to the Registrar. After applying, you will receive confirmation and further instructions about the Weekend.

#### HOW MUCH DOES IT COST?

The current cost is \$200 per participant. This Weekend charge is primarily associated with the cost for lodging, meals, and use of the retreat center. The staff pays their own costs as a "love" gift to the Program, and this enables the costs to be kept at a minimum. To assure that no one is prohibited the *Pilgrimage* experience due to cost, partial or full scholarships are available. Please discuss this option with the Registrar.

#### WHAT HAPPENS AFTER PRESBYTERIAN PILGRIMAGE?

The *Presbyterian Pilgrimage* Weekend is only a beginning! Your experience becomes a part of your life and provides a new perspective and inspiration for further Christian study and action in your local congregation and community. You will also have the opportunity to meet weekly in small groups, reinforcing each other as you share the Christian life. Larger groups meet less frequently to share the joy and fellowship of our faith with the broader *Pilgrimage* Community.

#### **IN SUMMARY:**

Seek God's guidance regarding the possible role of *Presbyterian Pilgrimage* in your faith journey. Many who attended had questions before their Weekend. However, after attending, they now actively seek the opportunity to share this wonderful gift from God with others. **Consider attending a weekend that will truly enrich your faith and your life!**
