

Draft Minutes of the One Hundred Fifty-Fifth Stated Meeting of The Presbytery of Arkansas University of the Ozarks, Clarksville, AR

March 1-2, 2024

Friday, March 1, 2024

The 155th Stated Meeting of the Presbytery of Arkansas was hosted by University of the Ozarks in Clarksville, Arkansas. The in-person meeting also was comprised of a livestreaming component on Friday and a Zoom with participation component Saturday.

Call to Order and Opening Prayer

The 155th Stated Meeting of the Presbytery of Arkansas was called to order by the gavel tapping and lighting the Christ candle, by Moderator RE Mike Szabo who said the opening prayer at 6:30 p.m. on March 1, 2024 at University of the Ozarks in Clarksville.

Welcome

Moderator Szabo welcomed everyone to the worship service and opening of the 155th Stated Meeting of the Presbytery of Arkansas. He introduced Lori McBee, Vice President for Advancement and Alumni Engagement for the University of the Ozarks. She welcomed everyone to the meeting and gave a brief rundown of the university's history and current events. She also discussed the Thriving in Ministry grant from the Lilly Foundation and Phil Blackburn, who will go full time with the grant this year.

Moderator Szabo called on Stated Clerk Brinegar who described the hybrid meeting and said that there will be no voting on Friday, just streaming. The Consent Agenda will be moved to Saturday morning. Voting will be held Saturday in person and from Zoom.

Moderator Szabo asked for four volunteers to be tellers for the meeting. He announced that the appointed tellers were: Judi McMillan, pastor of Presbyterian Church of Bella Vista; David Clark, commissioned pastor at First Presbyterian in Heber Springs; Alice Kutz, commissioner from First Presbyterian in Springdale; Katie Cummings, pastor at First Presbyterian in Bentonville.

General Presbyter's Report

General Presbyter MWS Stewart Smith welcomed all attendees including corresponding members, first-time commissioners, and visitors. Commissioners who were attending for the first time were:

Moderator Szabo asked the General Presbyter to give his report to the presbytery. General Presbyter Smith reported that the Synod of the Sun has elected a new leader, Rev. Mitch Miller, Santa Fe Presbyterian Church in Edmond, Oklahoma, who will start his new position in the summer. He introduced Kathy Lee-Cornell, who is the director of the Synod Partnership for Disaster Recovery. She said that she has been in her position for 18 months and this partnership of all 11 presbyteries in the synod was the first of its kind. She appreciates all of the support she has received and she encourages continued support for the Presbytery of Arkansas subcommittee on disaster preparedness.

General Presbyter Smith said that he plans to transition out of the general presbyter's position in 2024 after serving for eight years. He will be looking for transitional work and his last day at the presbytery will be August 2, 2024. He described motions the Coordinating Team will be bringing regarding this transition. He said that disciplinary charges will be read, four presentations will be given tomorrow asking for funding and about money received from the property sale of the Argenta and Brinkley and funds from Westminster in Little Rock. He offered a word of thanks to Jeremy Wilhelmi for his help in preparing for this stated meeting.

Worship and Installation of Moderator Emmett Powers

The meeting was moved to worship. Sacrament of the Lord's Supper was observed. The offering totaled \$728.00 to benefit the University of the Ozarks Presbytery of Arkansas Scholarship. Emmett Powers was installed as the next moderator of the presbytery for 2024.

Everyone was invited to gather downstairs from the sanctuary, for a reception following worship. The meeting was adjourned until 8:30 a.m. Saturday morning.

Saturday, March 2, 2024

Call Back to Order with Worship and Vice Moderator Installation

The 155th Stated Meeting of the Presbytery of Arkansas continued Saturday morning with Moderator Emmett Powers calling the 155th Meeting of the Presbytery of Arkansas back to order at 8:30 am, and

opened the meeting with prayer. A worship service was held with Rev. Stewart Smith and Julie Price with music. Vice Moderator Judi McMillan was installed by Moderator Emmett Powers. RE Mike Szabo is now the moderator of the Coordinating Team.

Consent Agenda

A quorum for the stated meeting is at least 20 Ruling Elders and 20 Ministers of the Word and Sacrament with at least 20 congregations represented overall, as approved at the February 10, 2018 Stated Meeting. A quorum was present with a total of 146 in attendance and on Zoom, of whom 117 could vote. The attendance is included in the Appendix as Section I.

Moderator Powers called on Stated Clerk Brinegar to present the Consent Agenda. The moderator explained all motions may be voted on as in total or anyone is welcome to remove any item for discussion. Moderator Powers asked if anyone wanted an item removed. No changes were made. Moderator Powers entertained a motion, one was made and seconded. The motion passed unanimously. The consent agenda may be found in the Appendix, Section II.

Stated Clerk Brinegar explained the technology of Zoom and welcomed attendees on Zoom and explained the electronic voting process. Technical Moderator Katie Flood was monitoring Zoom to help with questions and counting votes.

Order of the Day-Ministry Architects Report

At 9 a.m., Ministry Architects joined the meeting via Zoom and Mark Devries gave a report on their activities and the visioning process the presbytery is undertaking. The plan is set to take about 17 months. A question and answer period was held after the presentation.

Announcements

Two corresponding members were in attendance: Josh Kerr from the Presbyterian Foundation and Kathy Lee-Cornell, director of the Synod Partnership for Disaster Recovery.

Alice Kutz from Springdale announced the registration for the Presbyterian Women Spring Gathering at Ferncliff April 12 & 13, 2024.

John Arnold announced an April Workshop called Persuasive Promotion, sign up by QR code on tables.

Julie Price announced that there will be a Job Board on the presbytery's website for job postings in churches. She was asking for job listings, any type of position to be emailed to her. She also added that there is a part time position at Trinity Presbyterian for an educator.

Peg David invited everyone to attend the Presbytery Pilgrimage to be held at Ferncliff on April 18-21.

Stewart Smith announced that the next step in the visioning process is the visioning retreat to be held at Ferncliff on April 15. Encouraged committee members, committee chairs and anyone else interested in the process to attend.

Presentations

Joel Gill and Jocelyn Wildwright gave a presentation about Ferncliff future plans regarding remodeling and restoration to occur at the Ferncliff campus. He said that they have been in a visioning process for the last three years. He described renovations that will be made at Ferncliff. Their goal is \$7.6 million dollars; they have already raised \$3.85 million and are pursuing grants from the Maybe Foundation and Walton Family Foundation and are looking to raise \$1.52 million by January 9, 2025. He is suggesting 10% of the goal or approximately \$760,000 to support this campaign from the presbytery. He said that the donation could be a pledge over a time period of less than five years. Joel said that this is allowed by the grants they are seeking from the foundations. He said that every dollar raised can be turned into \$3 by the foundation matches.

Donna Mahurin and Kerri Daniels gave a presentation regarding the 2023 Centennial Celebration that Vera Lloyd Presbyterian Family Services just celebrated and the preparations they are making to serve the next 100 years. They had a campus master plan created in 2022 that the first renovation is the multi-purpose gym. The estimated price is over one million dollars with the first phase at a cost of around \$500,000. They have already raised \$400,000 to date and are asking the presbytery for a gift of \$250,000 to complete the renovations on the gym and set up a \$150,000 maintenance fund for the facility. Phase two would begin when they have the funds to start the project, which will include updating the housing for residents.

Phil Blackburn has been working with the University of the Ozarks Thriving in Ministry grant from the Lilly Foundation and is starting the third year of the grant. The program has created two cohorts in the Presbytery of Arkansas, one for Ministers of the Word Sacrament and Commissioned Ruling Elders. They also held the first retreat for the CREs in 2023. In January 2024 the next part of the grant is Thriving Rural Congregations in the POA with a one million dollar grant, which has two full time people working on it now. He said new cohorts will form, they will expand their work with Ruling Elders and write a sustainability grant for the long term. Lilly will match \$1 to \$1 up to \$500,000 for sustainability and they are asking for the match amount.

Business of the Presbytery

Coordinating Team Report

Committee Moderator RE Mike Szabo gave the report for the Coordinating Team, the written report may be found in the Appendix, Section III with four action items. Moderator Szabo asked if there were any questions, none were asked.

Motions for Presbytery Action

Motion 1: That the presbytery search for a Transitional General Presbyter. A motion was made from a committee so no is second required. No questions were asked, motion carried.

Motion 2: That Nominations will bring the names of 3-5 people to the Coordinating Team by April 1, who will elect the Transitional General Presbyter Search Committee on behalf of the presbytery. A motion was made from a committee so no second is required. No questions were asked, motion carried.

Motion 3: That a task force be formed to study the requests brought from today's presentations from Ferncliff, Vera Lloyd, Thriving in Ministry, and the suggestions for possible uses of the sale of First Presbyterian North Little Rock from the AC, and report back to presbytery with a planned response for presbytery approval. A motion was made from a committee so no second is required. The motion was amended to include report back to the June presbytery meeting. Motion carried after the lunch break.

Motion 4: The task force consist of a member from the Committee on Administration, a member from the Future of the Church Committee, a member from the Mission of the Church Committee, the Presbytery Treasurer, the General Presbyter and the Stated Clerk. A motion was made from a committee so no second is required. The motion was amended to include plus one at-large committee member elected by the Nominating Committee. Motion carried after the lunch break.

Order of the Day—Report from Youth at Presbytery

Youth Co-Moderator Lizzie Howard reported to the presbytery meeting about the youth events from 2023. She continued with events planned for 2024 to include confirmation classes, Mission Possible, High School Sabbath Saturday, Montreat for both high schoolers and middle schoolers.

Lunch Break

Business of the Presbytery Continues

Stated Clerk Blake Brinegar repeated for clarity, motions 3 & 4 from the Coordinating Team report and asked for questions, there were none. Votes were taken and both passed unanimously.

Josh Kerr, Ministry Relations Officer from the Presbyterian Foundation introduced himself and explained what he does at the foundation. He is available to help work with pastors and congregations with stewardship.

Stated Clerk Report

Stated Clerk Blake Brinegar's written report can be found in the Appendix, Section IV. The item for action:

At the 154th Meeting of the Presbytery of Arkansas the Nominations Committee in consultation with the Committee on Representation moved, That the Presbytery of Arkansas instruct the Coordinating Team, in consultation with the Stated Clerk, to return to the March 2024 Stated Meeting of the presbytery with necessary revisions to the presbytery by-laws, standing rules, and other policies to reduce the size of the Committee on Representation from nine (9) members in three (3) equal classes to three (3) members in three (3) equal classes. The motion was made and seconded. No questions were

asked. **Motion approved.** See the Presbytery Ministry Manual Part 1: Organization and Structure page in the Appendix, Section IV.

The stated clerk read charges against Steven Frazier.

CHARGES AGAINST REV. STEPHEN FRAZIER INVESTIGATIVE COMMITTEE, PRESBYTERY OF ARKANSAS PRESBYTERIAN CHURCH, U.S.A

January 26, 2024

The Presbyterian Church (U.S.A.) charges you, Steven Frazier, a teaching elder, with the following offenses:

- 1. Between September 1989 and June 1990, you committed the offense of sexual abuse by engaging in a course of sexual conduct by means of
- a) physical contact (a prolonged hug; a swat on the butt) that, while not explicitly sexual in nature, was inappropriate and
- b) inappropriate nonphysical intimacy
- in relation to a person who was then a minor 14 to 15 years old and with whom you had a teaching and coaching relationship. This course of conduct constituted sexual grooming of the minor and took place where you were a teacher/coach and the minor was a student, and at other school-associated locations.
- 2. Between September 1990 and June 1991, you committed the offense of sexual abuse by engaging in a course of sexual conduct by means of
- a) physical contact (two hugs) that, while not explicitly sexual in nature, was inappropriate and
- b) inappropriate nonphysical intimacy
- in relation to a person who was then 15 to 16 years old and with whom you previously had a teaching and coaching relationship. This course of conduct constituted sexual grooming of the minor and took place where you were a teacher/coach and the minor was a student.
- 3. On multiple occasions beginning in or around July 1991 and continuing until in or around October 1991, you committed the offense of sexual abuse by engaging in sexual conduct in relation to a person who was then 16 years old and with whom you previously had a teaching and coaching relationship and who served as your assistant in your role as a basketball coach. These actions took place in various locations related to where you were a coach, and a teacher and the minor was a student.

- 4. On multiple occasions beginning in or around October 1991 and continuing until in or around December 1991 or January 1992, you committed the offense of sexual abuse by engaging in sexual conduct in relation to a person who was then 16 years old and with whom you had previously had a teaching and coaching relationship.
- 5. Beginning in on or around December 1991 and continuing through sometime prior to May 1992, you committed the offense of sexual abuse by engaging in a course of sexual
- conduct by means of inappropriate non-physical intimacy (e.g. intimate correspondence that stated, "I love you" or was signed with "Love"; concealing the relationship from family) in relation to a person who was then 16 years old and with whom you had previously had a teaching and coaching relationship. This conduct constituted sexual grooming of a minor.
- 6. On multiple occasions beginning in or around June 1992 and continuing through December 1992, you committed the offense of sexual abuse by engaging in sexual conduct in relation to a person who was then 17 years old and with whom you had previously had a teaching and coaching relationship.
- 7. In December 1992, you committed the offense of sexual abuse when, to further a course of sexual conduct in relation to a minor with whom you had previously had a teaching and coaching relationship, you made a purported offer of marriage to the minor, who was then 17 years old.
- 8. On multiple occasions between approximately December 1992 and April 1993, you committed the offense of sexual abuse by engaging in sexual conduct in relation to a person who was then 17 years old, with whom you previously had a teaching and coaching relationship.
- 9. In or around September 1993, you committed the offense of sexual abuse by engaging in sexual intercourse with a former student who was then 18 years of age. This sexual conduct was inherently coercive because of the emotional dependency you fostered in the former student through years of sexual grooming and sexual conduct while the former student was a minor.
- 10. In or around September 1993, you committed the offense of sexual abuse by engaging in sexual intercourse with a former student who was then 18 years of age. This sexual conduct involved the misuse of your position as the former teacher and coach of the 18-year-old and/or as a student at the Presbyterian School of Christian Education.
- 11. In November 1993, you committed the offense of sexual abuse when, to further a course of sexual conduct involving coercion, misuse of position, or both, you induced a person, then 18 years of age, to get an abortion. These actions involved coercion by means of threats of financial and emotional consequences if the sexual relationship between you and your former student was discovered.
- 12. On multiple occasions between April 1993 and May 1997, you committed the offense of sexual abuse by engaging in sexual conduct, including sexual intercourse, with a person then 18 to 22 years of age.

13. On multiple occasions between April 1993 and May 1997, you committed the offense of sexual abuse by engaging in sexual conduct, including sexual intercourse, with a former student then 18 to 22 years of age. This sexual conduct involved the misuse of your position as the former teacher and coach of the 18 to 22-year old, as an Inquirer, and/or as an intern.

Stated Clerk Brinegar concluded his report, he asked MWS Georgia Senor to lead the presbytery in a prayer.

Committee on Nominations

MWS Judi McMillan did not have a written report but due to the Coordinating Team motions approved by the presbytery today, she requested that names be sent to her or Robert Lowry by April 1, for the Transitional General Presbytery Search Committee. She also requested that names be sent for the at-large committee member to be elected by the nominating committee to the task force to study the request of funds brought from today's presentations.

Committee on Administration Report

The Appendix, Section V, has the 2024 Asking Budget and the financial reports and the revised Small Church Loan Agreement. Treasurer Tom Verdery had two motions for presbytery approval.

For Presbytery Action:

Motion 1: The Committee on Administration recommends the following terms of call for General Presbyter Stewart Smith.

Note 1 - Amounts are unchanged from 2023 except for the increase in Board of Pensions dues.

Note 2 – Stewart is enrolled in the Board of Pensions "Minister's Choice" option and not Pastor's Participation.

The motion came from a committee and did not need a second. Questions were asked and answered. **The motion carried without opposition.**

Tom Verdery presented the 2024 Asking Budget which was very similar to the budget from 2023 with a reduction in Mission Acceptance or money from congregations. He asked for questions, there were none. Motion carried unanimously.

Committee on Ministry Report

Committee Moderator MWS Leslie Roper gave the report for the Committee on Ministry with four action items, the written report can be found in the Appendix, Section VI.

For Action:

- 1. Motion to grant retirement status to MWS Steven Kurtz effective December 31, 2023 and to approve the dissolution of call of MWS Steven Kurtz as pastor of Central Presbyterian Church, Fort Smith, AR concurring with the dissolution of call in a duly called congregational meeting on December, 31,2023. No questions were asked, motion carried.
- 2. Motion to grant retirement status to MWS Mark Clark (member at large) effective February 29, 2024. No questions were asked, motion carried.
- 3. Motion to recognize retirement status to Kenneth and Claire Rhodes effective December 31, 2023 and to express our gratitude to God for their faithful years of service to the West End Presbyterian Church of Arkadelphia. They were recognized for their work, no questions were asked, motion carried.
- 4. Necrology. The Committee on Ministry requests a moment of silence to reflect on the life and ministry of the following:

Rev. Jim Miller

whose work on this earth has ended, and who have received their reward and are at home with God and all the saints in the Kingdom of God. The presbytery held a moment of silence to honor their life and ministry.

Mission of the Church Committee Report

Committee Moderator CRE Peg Falls-Corbitt gave a report on the Mission of the Church grants. The next round of grants deadline is April 15 and the presbytery website has the grant application guidelines. A copy of the grant guidelines can be found in the Appendix, Section VII.

Honduras Covenant

MWS Phil Butin reported that a mission trip to Honduras is planned during spring break. Among the attendees, there are five international students and three MSWs-Jesse Gonzales, Jeremy Wilhelmi and himself. They will be putting a roof on a new church in El Rosario. He made a **motion have the presbytery approve the following covenant:**

A Covenant Between the Presbytery of Arkansas and the Presbytery of Honduras

- I. Goals of the Partnership
 - a. Mutual friendship, solidarity, fellowship, and support.
 - b. A deeper mutual awareness of the global scope of God's work in and through the church of Jesus Christ, and the ways it takes various forms in different cultural contexts.
 - c. Mutual encouragement in Christian discipleship and shared worship that includes faith sharing, mutual prayer commitment and support, and joyful, creative interchange of cultural expressions of discipleship and worship.
 - d. Mutual address of shared concerns:
 - i. Sharing God's love and grace with neighbors from all walks of life.
 - ii. Serving those in need in our churches and communities, especially for pure, safe water; solar power; adequate housing; and the basic necessities of life.
 - iii. Specific ways our churches can help address human needs and guard human dignity, safety, and flourishing in the midst of changing patterns of international immigration.
 - iv. Mutual support of theological education and leadership development that will help ensure faithful, growing congregations and new church development.
 - v. Mutual commitment to maintaining safe and functional church buildings for existing and new congregations, and homes for retiring pastors as needed.

II. Financial Matters

- a. Based on available resources and needs, the Presbytery of Arkansas (through its congregations) will joyfully assist in funding needed materials for projects undertaken under the direction of the Presbytery of Honduras.
- b. In the spirit of generosity, the financial costs of international and internal travel needed to sustain and deepen our partnership (whether to Honduras or to the United States for shared events, retreats, church gatherings, etc.) will be shared in ways that reflect the greater available financial resources among U.S. Presbyterians and churches.
- III. This covenant will be reviewed every three years, to reflect the changing realities, resources, and needs of both presbyteries.

The motion was seconded and questions were asked and answered. Motion carried.

Report from Young Adult Ministry

Sarah Leer, presbytery transitional youth and young adult developer, reported on the young adult ministry including Montreat camp that was for college age students was held with 20 from UCM, Lyon and Ozarks attending. She reported on UCM activities including their bike-a-thon and the SOS food pantry that has been set up for students at Lyon.

Future of the Church Committee Report

Moderator Cindy Lanphear, moderator of the committee told everyone that the next round of grants deadline is April 15 and the presbytery website has the grant application guidelines. A copy of the grant guidelines can be found in the Appendix, Section VIII.

New Business

Scharmel Roussel brought a **motion to concur with Overture 14**, *On Becoming Free from Plastic Pollution*, which can be found in the Appendix, Section IX. Motion was seconded. Questions were asked and answered. Motion passed.

Carol Young, on Zoom, brought a **motion to concur with Overture 7**, *Adoption of the Sustainable Peace Pledge*, which can be found in the Appendix, Section X. Motion was seconded. Questions were asked and answered. Vote was taken, tellers counted 42 yes and 16 no (Zoom votes included). Motion carried.

MWS Elizabeth Brinegar brought a motion to direct the Coordinating Team to evaluate the efficacy and continued use of hybrid meetings. Motion was seconded. Discussion was held and Move the Question motion was made. It was seconded. The original motion was carried to direct the Coordinating Team to evaluate hybrid meetings.

Closing Prayer and Adjournment

With no more business needing to be conducted before the presbytery, Moderator Emmett Powers offered the closing prayer and the meeting was adjourned at 2:45 p.m.

Section II, Exhibit A

Report of the Administrative Commission Park Hill Presbyterian Church, NLR November 15, 2023

The Administrative Commission appointed to work with the Session of Park Hill Presbyterian Church met with the Session and Transitional Pastor Carl McCormack on November 2, 2023, to give Session members a sense of how we see the congregation's future prospects for healthy and productive ministry, in light of the crisis in the congregation over the last couple of years.

We told them that our job has been to listen and, according to these words taken from the Presbytery's charge to the AC, "counsel the Session of Park Hill Presbyterian Church in the discernment of God's future for the congregation." We also told them that, as we have been listening for almost a year, we have been impressed by the hopeful spirit they have manifested and by their responses to Carl's leadership. Further, we told them that we have been struck by the near-total absence of any discussion of the crisis the congregation has experienced and that our purpose in the meeting of November 2 was to give them our thoughts on the future and to answer any questions they might have.

The immediate response by a couple of Session members was that they feel "talked out" about the crisis and that the general feeling was that they had agreed to "push forward" without further discussion with the remaining membership they have and try to make the best of it. We assured them that no one wants to reopen or revisit the entirety of the crisis, how it began, and how it was handled, but that our strong advice is that they do two things: (1) pursue healing and reconciliation and (2) prepare the congregation to call its next installed pastor, no matter how far in the future that search may take place, especially in light of the fact that prospective candidates for the position will have questions about the drop-off in membership and giving the congregation experienced between 2021 and '23. Regarding the first point, the AC's advice was that Session members cannot wait for people to come forward and say they feel betrayed and abandoned, that that is not the responsibility of the injured, but that the Session needs to take the initiative with those people. Regarding the second point, there was particular concern that it might not be possible to find five or six members to serve on a Pastor Nominating Committee who could agree on how to describe the crisis and its aftermath. We said that, nonetheless, something needs to be put in writing now, including the counsel of the AC, while it is fresh in people's minds.

Carl added that he has seen at Park Hill a "reluctance to take responsibility" and a lack of transparency about the crisis, especially having to do with the congregational meeting in February of 2022 that precipitated the departure of so many members. He also expressed concern that there doesn't seem to be much "movement" toward being ready to accept visitors and prospective members and that there may be increasing opportunities to welcome members of immigrant, minority, and/or LGBTQ communities especially. He said Park Hill has got to be willing to let God show them the kind of church they can be.

Based on responses to what we and Carl said, the AC members had the sense that the Session is ready to follow our recommendations, especially as they prepare for Carol Clark's return to the role of Transitional Pastor. They seemed receptive to suggestions that they find ways to get groups of Park Hill members involved in ministry work directly tied to the life of Presbyterian-related institutions such as Presbyterian Village, which can help them strengthen relationships among themselves and give prospective members a look at how they work in ministry

beyond themselves. The sense of the meeting, as Quakers might say, grew to be that they were ready to move forward without the AC's presence, though we pressed them to make sure they felt that way. There was some back-and-forth about that, but it came down to the acceptance that any of us would still be available, as individual friends of the congregation, to offer suggestions and to look over drafts of documents, if needed, and that we were prepared to write the Presbytery and say we believe our work is done and that the Session of Park Hill has agreed to do the following two things:

- 1. Engage in a process of healing and reconciliation of their design, focusing both on people who are still in the congregation and those who have left
- 2. Create a file that can be given to a future PNC, describing the crisis and its aftermath, which can include the acknowledgement that there are multiple versions of what happened and what it meant

Given what has been stated above, it is the request of the Administrative Commission assigned to work with the Session of Park Hill Presbyterian Church that this AC be dismissed.

Report of the Administrative Commission for First Presbyterian Church of North Little Rock March 2, 2024

After four years of prayerful discernment regarding the property of First Presbyterian Church of North Little Rock, the AC approved the sale of the property to Allen Engstrom for one million dollars. The closing occurred on December 29, 2023 with the presbytery receiving proceeds of \$ 975, 123.62. Expenses incurred by the AC totaled 40,380 which will be repaid which leaves a net proceeds to the presbytery of 934,743.62.

The Administrative Commission would like to recommend the following use of the proceeds from the sale.

- 1. A \$50,000 gift to "The Van", a ministry that serves the homeless population of Little Rock and North Little Rock and a mission partner of 1st North Little Rock.
- 2. A \$50,000 gift to Ferncliff, another mission partner of 1st North Little Rock.
- 3. 100,000 undesignated to the Presbytery of Arkansas.
- 4. To establish a fund with the remaining proceeds (734,743.62) to give direct support to congregations in the Presbytery of Arkansas. We recommend that oversight of the fund be from the Future of the Church Committee and that interest and principal would be used to support congregations in a variety of ways. We recommend that the funds be unfettered from over regulation/over stipulation in order to ensure that the funds will be used.

RESOLUTION OF THE PRESBYTERY OF ARKANSAS

The PRESBYTERY OF ARKANSAS, an Arkansas non-profit corporation (the "Presbytery"), acting by and through the Administrative Commission for First Presbyterian Church, North Little Rock/Argenta (the "Administrative Commission"), meeting after having provided any required notice, passed the following resolution:

WHEREAS, until its dissolution on December 14, 2023, First Presbyterian Church of North Little Rock (the "Church") was a congregation of the Presbyterian Church (U.S.A.) and subject to the Constitution of the Presbyterian Church (U.S.A.).

WHEREAS, under Section G-4.203 of the Constitution of the Presbyterian Church (U.S.A.) "[a]ll property held by or for a congregation . . ., whether legal title is lodged in a corporation, a trustee or trustees, or an unincorporated association . . . is held in trust nevertheless of the use and benefit of the Presbyterian Church (U.S.A.)."

WHEREAS, under Section G-3.0301(a) of the Constitution of the Presbyterian Church (U.S.A.), each congregation falls within the jurisdiction of a presbytery. The responsibilities of each presbytery include "organizing, receiving, merging, dismissing, and dissolving congregations in consultation with their members."

WHEREAS, the Presbytery of Arkansas is a duly constituted presbytery of the Presbyterian Church (U.S.A.) with jurisdiction over churches in the northern part of Arkansas.

WHEREAS, until its dissolution on December 14, 2023, the Church fell within the jurisdiction of the Presbytery of Arkansas.

WHEREAS, in 2019, the Presbytery formed the Administrative Commission and empowered the Administrative Commission to, among other things, "[a]ssume original jurisdiction of the [C]hurch" and "[s]ell or encumber any real property" of the Church.

WHEREAS, under Section G-3.0303(e) of the Book of Order, the Presbytery has authority to "assume original jurisdiction [over any church within its jurisdiction] in any situation in which it determines that a session [the governing body of the church] cannot exercise its authority."

WHEREAS, on December 19, 2019, the session of the Church met with the Administrative Commission and requested that the Administrative Commission assume original jurisdiction of the Church.

WHEREAS, also on December 19, 2019, the Administrative Commission assumed original jurisdiction of the Church.

WHEREAS, on December 14, 2023, the Presbytery of Arkansas, acting by and through the Coordinating Team, formally dissolved the Church.

WHEREAS, under Section G-4.0205 of the Constitution of the Presbyterian Church (U.S.A.), "[w]henever a congregation is formally dissolved by the presbytery . . . such property as it may have shall be held, used, and

applied for such uses, purposes, and trusts as the presbytery may direct . . . or such property may be sold or disposed of as the presbytery may direct, in conformity with the Constitution of the Presbyterian Church (U.S.A.)."

WHEREAS, the Presbytery desires to convey the property described in Exhibit A to Regal Beagle Holdings, LLC.

WHEREAS, the Presbytery wishes to authorize the General Presbyter to execute any and all documents necessary to consummate the conveyance of the property described in Exhibit A to Regal Beagle Holdings, LLC.

NOW, THEREFORE, BE IT:

RESOLVED, that the Presbytery authorizes the transfer of the real property described in Exhibit A to Regal Beagle Holdings, LLC; and

FURTHER RESOLVED, that Stewart Smith, General Presbyter of the Presbytery (the "Authorized Officer"), is hereby authorized, directed, and empowered to execute and deliver any and all documents on behalf of the Presbytery which may be required to consummate the transfer, including but not limited to deeds and all other related instruments and documents of every kind and character as the Authorized Officer may in his sole discretion deem necessary, advisable, or proper in connection with the consummation of the transfer.

Approved Amendment PRESBYTERY OF ARKANSAS SMALL CHURCH DIRECT LOAN POLICY

October 10, 2008 Revised December 14, 2023

Direct loans are small loans from the Presbytery of Arkansas Small Church Loan Fund to qualified churches for capital repairs, ministry initiatives, or "extreme makeovers" for struggling congregations participating in the Small Church Loan initiative of the Presbytery.

To qualify for this loan, a church should show a need to be financed by the Presbytery. Ordinarily, the interest rate will be zero (0) percent and the maximum amount of a loan will be \$25,000 per church.

The maximum term of any loan shall be ten years. The term of each loan will be determined on a case by case basis. If church property is sold before the loan is repaid, the small church loan will be repaid to the Presbytery after any Superior Liens are paid and before any other funds are disbursed.

Total loans will not exceed the total amount in the Small Church Loan Fund.

All requests must go to the Committee on Administration for approval.

An application would require:

- Plans and purposes for the loan
- Explanations of how the loan fits into the church's mission and vision
- Current membership and average weekly attendance
- Description and value of church properties
- Current financial situation

Applications would include the following

- Narrative explanation for the request
- Contributions and Operating Expenses for prior three years
- Session Approved Annual Budget

Retired Minister of Word and Sacrament and member of the Presbytery of Arkansas, Rev. Dr. John Barklind died at his home on Friday, October 13, 2023.

Most recently, John served the First Presbyterian Church in Beebe, preaching once a month and moderating the session.

He was employed twice with the Ouachita Area Council in Hot Springs as District Scout Executive and in the Tri-Trails Council of North Platte, Nebraska. A licensed Arkansas insurance agent and broker continuously since 1970, he held non-resident licenses in eight other states in order to serve clients there. As a trained Estate Planning Consultant brokered the products of 124 insurance companies. He was a lifelong student, through certificate training courses and avid reading in his extensive library. He was honored as a 60-year Veteran of volunteer and professional service to the Boy Scouts of America and recipient of the Order of the Arrow Vigil Honor and the B.S.A. Silver Beaver Award. Hartley lived a

Mission Initiative Grants

GUIDELINES FOR FUNDING FROM MISSION INITIATIVE GRANTS BUDGET

THE PURPOSE of funding for the Mission Initiative Grant portion of the Mission of the Church Committee's budget is to assist congregations and ministries of the Presbytery of Arkansas in proclaiming the love of Christ beyond their walls; efforts that extend the power of congregations and ministries to serve the most vulnerable in our society are particularly welcome.

Application Process

- 1. The Mission of the Church Committee receives and acts on grant proposals three times a year. The three submission deadlines are as follows: April 15, July 15, and October 15.
- 2. A request to the Mission of the Church Ministry Area should include a written proposal, no longer than two pages detailing:
 - a. the amount of funding requested;
 - b. the need or needs the Session or Ministry wants to address with that funding;
 - c. a brief description of specific goals of the project and how the funds requested will be used; d. a copy of the budget for the project;
 - **e.** total estimated costs and other sources of funding that are committed or have been applied

for:

- f. the date the Session or Ministry approved the request,
- g. Session's *or* Ministry's designated contact for the project, including name, address, telephone number and email address;
- h. name of Treasurer or other administrative official to whose attention the check should be sent.

The proposal should be sent as an attachment emailed to Peg Falls-Corbitt (fallscorbitt@hendrix.edu), Moderator of Mission Committee, AR Presbytery.

Please include the church or ministry name in the title of the attachment and subject line of email. For example: [church name].Mission Initiative Grant 2024

Other Details:

- 3. The Committee's budget is limited, and **requests of more than \$1,500** are generally not **approved**. However, there may be occasions when a larger amount could be granted: a. if the applicant can make a case for it, and
- b. if they have made a good-faith effort to secure other funds but are still short of their goal.

- 4. The Mission of the Church Committee will give priority to requests where:
 - a. the applicant is addressing this need with their own gift or gifts;
 - b. other sources of funding have been secured or are being sought.
- 5. Please note that part of the mission of the Future of the Church Committee is to "Assist churches to re-develop their mission and ministry" and to "Assist congregations seeking funding or grants" to help in that process. The mission of that Committee and this one are somewhat similar but are not the same, and it may be that a request to that ministry area would be more appropriate.

The Committee reviews and acts on applications within 30 days of each deadline.

FOTC Grant Guidelines Application 2024

Purpose of the Future of the Church committee. The Future of the Church (FOTC) committee of the Presbytery of Arkansas serves as a catalyst to engage congregations and Presbytery Ministry Areas in creative thinking and planning beyond current models of ministry and programming. The Future of the Church committee assists with visioning, branding, technology, and development of new ministries and supports new church developments of the Presbytery.

Purpose of the Grants. There are two aims of the FOTC grants: (1) supporting congregations in extending their ministries to reach new communities or populations, as well as; (2) encouraging congregational growth, vitality and mission.

Eligibility and Timeframe. The FOTC is accepting one year proposals from Presbyterian churches within the Presbytery of Arkansas. Completed Application Forms will be received from **February 15** –**April 15**. The funding year is from August 1 to July 30. Funding may be applied for again, for a total of three years.

Application Guidelines. The following factors are considered although not exclusively in reviewing proposals:

- Potential benefit to the congregation
- Potential benefit to new populations or communities Capacity of your organization to achieve the result outlined Evidence of a plan for evaluating the project or program Potential for sustainability beyond the grant period
- Evidence of cooperation or collaboration with other organizations Innovation and creativity of the approach
- Evidence of support for at least one of the 3 prongs of the Matthew 25 Initiative: Building Congregational Vitality; Dismantling Structural Racism; Eradicating Systematic Poverty.

Each request is considered on its own merits. The following requests would generally be denied:

- Support for routine facility improvements, maintenance, or upkeep.
- Multi-year proposals
- Projects that are partisan (i.e. favor one political party over another). For example, a project aimed at
 expanding the child income tax credit which reduces poverty without favoring one party or another, would
 be considered. A project that sends money to a political party to support the issue would not be considered.
 We will support projects aimed at dismantling structural racism and/or ending systematic poverty that rise
 above partisan interests.

Selection Process. FOTC reviews proposals based on the guidelines stated above. Generally, grants will be in the \$2000-\$5000 range. Notification of grant approval will be made in June with funds distributed in July.

Documentation. The FOTC expects a year-end project report so that the grants news can be shared with the Presbytery.

[OVT-014] On Becoming Free from Plastic Pollution

Recommendation

On Becoming Free from Plastic Pollution

The Presbytery of Arkansas overtures the 226th General Assembly (2024) of the Presbyterian Church (U.S.A.) to commit ourselves as a church, a people of faith and a social organization embodying Christian values, to:

- 1. Encourage all our settings to commit to changing from a disposable culture to a reusable, sustainable one.
- 2. Encourage education within our congregations and in our communities to advocate for alternatives to single use plastics, whether through mitigation efforts and campaigns or by supporting local and state bans on single use plastics, and
- 3. Encourage all settings of the Church to determine the best pathway forward for strategies and actions to mitigate plastic pollution, using as examples the following resources: a. The Story of Plastics, (95-minute documentary):
- b. Sierra Club Solutions to Plastic Pandemicii
- c. Ten Towns Ten actions Toolkit of New Hampshire iii
- d. National Environmental Education Foundation (NEEF): Join the Fight for Reducing Plastic Pollutioniv
- e. Break Free Plastics: resources, articles, list of the worst corporate polluters and suggestions for actionsv
- f. The Five Actions Congregations Can Take from the United Church of Christvi
- g. Presbyterians for Earthcare webinar and resources on becoming free from plasticsvii
- 4. Reduce the use of single-use plastics and packaging.
- 5. Commend all settings of the church to join in possible opportunities for participation in addressing plastic pollution including to: a. Encourage all settings of the Church to commit to change from the throwaway and disposable culture and consumptive practices to reusable and compostable products.viii
- b. Encourage replacement of single use plastics such as cutlery, plates, cups, straws, lids, and bottles with bioplastics, reusable, truly recyclable (like aluminum or paper) or compostable substitutes.
- c. Preach on ecological sustainability principles articulated by Sallie McFague on responsible use of ecological resources_{ix} and the sustainable goal of mitigating single-use plastics.
- d. Educate on the importance of mitigation of single-use plastics and plastic straws as well as plastic bottles at our churches, their events, and gatherings.
- e. Educate on the toxicity of plastic pollutions and microplastics to the health of our environment, to our own health, and the health of non-human life.
- f. Educate on policies and practices of local recycling and composting services and advocating for better practices.
- g. Organize low or zero waste events in collaboration with local organizations and infrastructures.
- h. Support businesses that use sustainable practices such as reusable containers and reusable bags.

- i. Participate in public cleanup of God's creation, including all bodies of water, parks, and beaches.x
- j. Install fountains for water bottles in church campuses, wherever possible.
- k. Actively support and lobby for local, state, national, and international legislation and policies that align with the intention of this resolution including bans of or fees on single use plastics.
- 1. Encourage the Mission Responsibility Through Investment Committee of the PC(USA) to engage with companies and corporations to reduce their production and use of plastics, particularly eliminating singleuse plastics wherever possible.
- 6. Acknowledge that accommodations in expectations need to be made for certain impacted groups such as those who are disabled or unhoused.
- 7. Encourage people in all settings to speak truth to the public square against plastic pollution of our planet.

Rationale

The 222nd General Assembly overwhelmingly agreed that "caring for God's creation" should be part of our constitution and this received concurrence of 150 Presbyteriesxi. Our Book of Order now states "God sends the Church to share in the stewardship of creation, preserving the goodness and glory of the earth God has made"xii and includes "caring for God's Creation" in the commitment to participate in Christ's mission. In keeping with this, all Presbyterians should seek to reduce the use of plastics, especially singleuse plastics, in their homes, churches, workplaces, communities, states and nation.

In 2023, our sisters and brothers in the United Church of Christ (UCC) General Synod passed the overture "Free from Plastic Pollution: A Resolution of Witness".xiii We overture the 226th General Assembly (2024) of the Presbyterian Church (U.S.A.) to join them. The UCC's Rationale can be found in their Resolution. The PC(USA) General Assembly has affirmed that creation care is a fundamental part of who we are as Presbyterians. The biblical mandate for the overture "On Amending G-1.0304, The Ministry of Members, by Adding "Caring for God's Creation"xiv by Dr. William P. Brown (William Marcellus McPheeters Professor of Old Testament at Columbia Theological Seminary) applies to our need to become free from plastic pollution as well:

The fundamental biblical mandate for creation care comes from Genesis 2:15, where God places Adam in the garden to "till it and keep it" (NRSV). A better translation from the Hebrew is "to serve it and to preserve it." In Genesis 1:26–28, God blesses humankind with dominion over the earth. Human "dominion" as intended in Genesis is best practiced in care for creation.

New Climate for Theology

In Christ "all things hold together" (Colossians 1:17), and "every creature under heaven" is to receive God's good news (v. 23). According to Revelation, God's work in the world is "make all things new" (21:5), to bring about a new creation that does not destroy the old but transforms it, renews it. If the church is the sign of the new creation, then the church must lead the way in caring for creation.

Since the UCC General Synod passed their Resolution of Witness, further evidence of the danger of plastics to God's Creation have been realized. Studies have found plastics in almost every food they tested, often at high levels.xv Water from disposable water bottles contains about 240,000 nanoparticles per liter.xvi Plastics in our bodies can have serious impacts on our health and inhaled plastics have been correlated with lung inflammation, shortness of breath and a higher risk of lung cancer.xvii These impacts disproportionately fall on vulnerable and disadvantaged communities. Mary Johnson (Harvard T.H. Chan School of Public Health) said, "Vulnerable populations are at even greater risk of the negative health impacts from the production, use and degradation of plastics".xviii Approximately 99 percent of plastic comes from fossil fuels, generating 3.4% of global greenhouse gas emissions.xviii Petrochemical companies have undertaken a massive increase in plastic production referred to as "Plan B for the fossil fuel industry".xviiiixxiiii Expanded the use of plastics serves to increase demand for fracked gas.xiix Leaked methane, the largest component of fracked gas, has 28 times as much impact on warming the climate as does carbon dioxidexx and is responsible for about 30% of the rise in global temperatures since the Industrial Revolution,xxi resulting in 2023 being the warmest year on record, by far.xxii And while governments and international bodies are trying to limit plastic production, petrochemical industries are working to weaken legislation and international treaties.

Currently, 430 million tons of plastic is produced *yearly* resulting in a production of 11 billion metric tons of plastic in the last century, surpassing the biomass of all animals on earth. Despite efforts to convince people recycling is effective, only 9% of the plastic ever produced has been recycled, and 19% has been incinerated.xxiv Plastics are now one of the largest environmental disasters on our planet, polluting the Earth we are passing on to our children and subsequent generations.

God placed Adam in the garden to serve it and to preserve it. It is time for the Presbyterian Church (USA) to preserve creation by becoming free from plastic pollution.

[OVT-007] Adoption of the Sustainable Peace Pledge

Source: Charleston-Atlantic Presbytery Event: 226th General Assembly (2024)

Concur: Presbytery of Arkansas

Recommendation

On Adopting The "Sustainable Peace Pledge"

The Presbytery of Charleston-Atlantic overtures the 226th General Assembly [2024] to adopt the following Sustainable Peace Pledge [1]:

"Sustainable peace entails the physical, material, psychological, cultural/religious, and ecological well-being of all peoples. We declare our organizational intention to pursue sustainable peace in our work and our lives"

and in adopting it to call upon:

- a. The Presbyterian Mission Agency to hold a consultation of relevant PC(USA) agencies and PC(USA)-related organizations to begin the process of developing a comprehensive, coordinated, global, and long-term strategy for contributing to the mitigation of the effects of climate change, which imperil "the physical, material, psychological, cultural/religious, and ecological well-being of all peoples."
- b. Representatives from other Christian denominations and other faith communities, but especially denominations of the World Communion of Reformed Churches, to be included in the consultation.
- c. Other councils of the PC(USA) to be encouraged to adopt this pledge and develop their own comprehensive, coordinated, global, and long-term strategies in concert with that of the Presbyterian Mission Agency.
- d. All members of the PC(USA) to be encouraged to personally adopt this pledge.
- e. The Presbyterian Mission Agency to report back to the 227th General Assembly [2026] on the progress toward establishing and implementing a comprehensive, coordinated, global, and long-term strategy for contributing to the mitigation of the causes and effects of climate change.

Rationale

Rationale

- 1. Earth is warming and will continue to do so for the foreseeable future. [3]
- 2. This warming, accelerated by human activity, is forcing changes in Earth's climate. The primary anthropogenic factor forcing climate change is increasing amounts of carbon dioxide, methane, and nitrous oxide in the atmosphere, causing a "greenhouse" effect, heating Earth. [4]
- 3. If no more greenhouse gasses were added to the atmosphere, methane would dissipate in about a decade and nitrous oxide in a bit over a century. [5], [6]
- 4. About 80% of carbon dioxide would be dissolved in the ocean over two centuries but the remainder would take millennia. In the process the ocean becomes more acidic. [7]
- 5. However, greenhouse gasses continue to be added to the atmosphere.
- 6. It is estimated that the level of temperature rise over the next century will overshoot current mitigation targets.
- 7. The consequences of climate change will affect virtually every aspect of human life and every human being on Earth.

- 8. The global consequences of climate change (e.g., wide-spread drought, frequency of wild fires, severe weather events, sea level rise, wide-scale flooding, species extinction, etc.) will increase in severity for successive generations even if global efforts to mitigate them are instituted today. [8]
- 9. In addition to these consequences for the global ecosystem, there will be pronounced human costs. These will include: wide-spread hunger, mass population migration, increased heat-related health challenges and diseases, increased global political violence. [9], [10], [11]
- 10. Scripture warns that the iniquities of the parents will be delivered upon the children for many generations (Exodus 20:5). Scripture also declares reasons for hope (Jeremiah 32:1- 9, Romans 8:38-39, Revelation 21:5). The opening chapter of Genesis shows God calling upon the existing creation to share in the creation of the future (Genesis 1:11, 20, 24). Scripture witnesses that present actions have consequences on future generations; that by the loving grace of God, the present is not fully determined by the past; and that we are called upon by God to help bring forth the new creation.
- 11. While some of the consequences of climate change are inevitable, their degree can be mitigated by concerted application of Godcalled human capacities of intellect and imagination. Efforts to mitigate the most severe consequences of climate change for future generations will need to be comprehensive, coordinated, global, and long- term. Such efforts need to include, at least [12]:
- a. Reducing, substantially, current levels of CO2 and other greenhouse gas emissions [13],
- b. Adopting non-CO2 emitting forms of energy production,
- c. Removing and sequestering CO2 from the ocean and atmosphere. [14]
- 12. The PC(USA) currently has formal or affiliated efforts that could address or are addressing some of the issues related to mitigating climate change. These include but are not limited to the Advisory Committee on Social Witness Policy; the Office of Public Witness; the Presbyterian Peacemaking Program; Mission Responsibility Through Investment; Presbyterians for Earth Care; and the Presbyterian Association on Science, Technology and the Christian Faith.
- 13. However, the PC(USA) does not currently have a comprehensive, coordinated, global, long-term strategy for its efforts to contribute to mitigating the consequences of climate change. Still, the PC(USA) has identified itself as a Matthew 25 Church, and the Presbyterian Mission Agency has taken the organizational lead in fulfilling that Matthew 25 commitment. [15]
- 14. The Presbyterian Mission Agency has adopted three primary foci and three intersectional priorities as means of fulfilling the Matthew 25 commitment. One of the intersectional priorities is climate change. Without significant mitigation of the already anticipated consequences of climate change, the issues related to the other Matthew 25 foci and priorities (i.e., building congregational vitality; dismantling structural racism; eradicating systemic poverty; gender justice and heteropatriarchy; militarism) will be exacerbated.
- 15. The Presbyterian Mission Agency is the fitting agency of the PC(USA) to coordinate the development of a comprehensive, coordinated, global, long-term strategy for contributing to the development of a sustainable peace that will incorporate all of the foci of the PC(USA) Matthew 25 initiative.
- 16. The Sustainable Peace Pledge itself does not provide such a strategy but it is a commitment to seek Shalom in relation to all people and all of God's creatures. The Pledge commits the PC(USA), as a body, to develop and implement a strategy to work toward a comprehensive, coordinated, global, and long-term effort to mitigate the worst consequences of global climate change and provide a foundation for an ecologically sustainable peace that would fulfill Matthew 25 goals.
- 17. The Pledge commits other Councils of the PC(USA) and individual PC(USA) members, if they adopt it, to work toward a comprehensive, coordinated, global, long-term effort to attain an ecologically sustainable peace.
- 18. The Pledge also commits the PC(USA) to engage in an ecumenical and interfaith effort to contribute to a comprehensive, coordinated, global, long-term effort to attain an ecologically sustainable peace beginning with engaging members of the World Communion of Reformed Churches.
