Motions for Presbytery Action

1. **The Committee on Nominations moves that the presbytery approve the slate of nominees presented in the committee's report.**
2. **The Committee on Nominations moves that the presbytery instruct the Coordinating Team to act on behalf of the presbytery to fill all unfilled positions on COM, CPM, Future of the Church, Committee on the Mission of the Church, University of the Ozarks Grant Coordination Team, and 1001 Working Group.**
3. **The Committee on Nominations moves that the presbytery instruct the Coordinating Team, with the advice of the Transitional Youth and Young Adult Developer and according to standing rules, name members of the classes of 2025, 2026, and 2027 for the Youth, Young Adults, and Campus Ministry Committee.**
4. **The Committee on Nominations moves that the presbytery determine that from the adjournment of the 157th Stated Meeting until the opening of the 158th Stated Meeting a quorum of the Coordinating Team shall be determined by the number of members currently in service.**

Rationale: There are three at-large positions still to be filled on the Coordinating Team. The CT has the authority to act on behalf of the presbytery between meetings on nominations. As a commission of the church, the CT may not act to expand its number or authority. Consequently, three positions will remain vacant until the 158th Stated Meeting. This action will permit the CT to continue its work without unnecessary interruption.
