

Mission Initiative Grants

In the April round of grant proposals a total of \$7535.44 was granted to six churches: First Alma; First Bentonville; First Dardanelle; First Jacksonville; Mt. Comfort; Wynne. Funds remaining to be distributed in July and October rounds: \$12,466.

The Committee asks that churches wishing to apply for future Mission Initiative Grants follow the guidelines in providing information to the committee. The Committee discussed other information that would be helpful and anticipates making changes in the near future.



GUIDELINES FOR FUNDING FROM MISSION INITIATIVE GRANTS BUDGET



Application Process

- 1. The Mission of the Church Committee receives and acts on grant proposals three times a year. The three submission deadlines are as follows: April 15, July 15, and October 15.
- **2.** A request to the Mission of the Church Ministry Area should include a written proposal, no longer than two pages, detailing:
 - a. the amount of funding requested;

- b. the need or needs the Session or Ministry wants to address with that funding;
- c. a brief description of specific goals of the project and how the funds requested will be used;
- d. a copy of the budget for the project;
- e. total estimated costs and other sources of funding that are committed or have been applied for;
- f. the date the Session or Ministry approved the request,
- g. Session's *or* Ministry's designated contact for the project, including name, address, telephone number and email address;
- h. name of Treasurer or other administrative official to whose attention the check should be sent.
- **3.** To submit your request:
 - i. Send the written proposal as an **attachment to an email** (not in the body of the email) to Peg Falls-Corbitt (fallscorbitt@hendrix.edu), Moderator of Mission Committee, AR Presbytery;
 - ii. Include the church or ministry name in the title of the attachment and subject line of email. For example: [church name]. Mission Initiative Grant 2025

- **4.** The Committee's budget is limited, and **requests of more than \$1,500 are generally not approved**. However, there may be occasions when a larger amount could be granted:
 - a. if the applicant can make a case for it, and
 - b. if they have made a good-faith effort to secure other funds but are still short of their goal.
- 5. The Mission of the Church Committee will give priority to requests where:
 - a. the applicant is addressing this need with their own gift or gifts;
 - b. other sources of funding have been secured or are being sought.

The Committee reviews and acts on applications within 30 days of each deadline. Revised 1/23/25

Honduras AR Presbytery Mission Team Returns with Renewed Spirit and Stronger Bonds

The Arkansas Presbytery Mission Team has returned safely from its 9th mission trip to Honduras, full of gratitude, stories, and strengthened friendships. From March 22–29, 2025, twenty dedicated participants representing churches across Arkansas and students from three colleges joined hands with our Honduran partners to continue our shared ministry grounded in faith, service, and love.





The team spent much of the week at Bethel Presbyterian Church in Guaimaca, where they tackled renovation projects alongside local church members. Funds were sent ahead to replace an aging, damaged roof just before the team arrived. The team's work included cleaning the worksite, building a block wall, and interior painting—all aimed at creating a safer and more welcoming environment for ministry. But even more meaningful than the physical work was the time spent in community: sharing meals, praying together, worshiping, singing, and laughing with old and new friends.

The group worshiped with the congregation at the Peña de Horeb Church in Tegucigalpa on their first Sunday. After, the two Presbyteries celebrated their covenant relationship with a signing ceremony. Later, they visited Cristo del Picacho Park to enjoy the night views of the capital and time together. The team also traveled to Puerto Grande as a day trip, which offered time to visit a more rural church, share a meal, and listen to their desires for future building and program expansion.

One of the trip highlights was visiting a local school for a morning. The students were instantly thrilled to see a new soccer ball and to welcome new playmates as they ran around the courtyard. Team members were divided into small groups in classrooms across the school, participating in Music, English, Home EC, Computer Class, and Library. Groups of excited children surrounded the team members, requesting signatures as if they were celebrities. Sheer joy on the children's faces was a powerful reminder that this continued relationship and small gestures can carry deep meaning for all involved. The school leadership and teachers were overjoyed at the visit.



The team stayed at Villa Gracia—a conference center run Presbyterian Women of Honduras, which once again warm and nurturing home base. From the early morning evening debriefs and mealtime devotionals, Villa Gracia sacred space for reflection and connection.

ended with a day of browsing souvenir shopping in Valle de Ángeles while Revs. Jesse Gonzales and Phil Butin visited churches of El Horno, El Sute, and El Inherto, further strengthening pastoral ties. The morning before departing, the team had a brief tour of Comayagua and saw the oldest working clock in the world.

We also said goodbye to Rev. Dori Hjalmarson, as PCUSA eliminated co-worker positions and closed the World Mission offices, citing constraints. Dori lived in Honduras for nearly 8 years and remains a to many. We wish her the best with God's plan for her future.

We thank everyone who supported this mission through prayer, gifts, and encouragement. Your generosity made it possible to extend not just through tools and materials, but through presence, partnership, purpose. Together, we raised over \$26,000 through the Synod of the Presbytery of Arkansas, churches, and individuals. These funds trip scholarships for team members, two guitars gifted to Villa Gracia visiting mission groups, a dozen Sunday School material kits, and 180 Bibles.

Faith Formation Resource Grant

Purpose

To provide seed money to support Presbytery of Arkansas congregations and ministries in creatively engaging their faith community in practices of faith formation, Christian education, spiritual growth, and discipleship.

Eligibility Criteria

To apply for the Faith Formation Resource Grant, applicants must:

- Be a congregation or validated ministry within the Presbytery of Arkansas.
- Propose a project that supports faith formation and spiritual growth.

Note: Individuals are not eligible to apply for this grant.

Grant Amount

Grants will be awarded up to a maximum of \$500.

Application Process

Submit a letter that includes:

- 1. Name of the church or validated ministry.
- 2. Contact person, their phone number, email address, and role in church ministry
- 3. Brief description of the proposed project.
- 4. Objectives and goals.
- 5. Target audience and desired outcomes.
- 6. List of items to be purchased with the funds and their approximate costs.
- 7. Total estimated budget.
- 8. Name of the church or ministry treasurer to whom the check should be mailed, along with the mailing address.

Submissions must be received by June 30.

To Submit Your Application

- 1. Send your written proposal as an attachment to an email (not in the body of the email) to the moderator of the Resource team, Tasha Blackburn at tasha@lpres.org
- 2. Include the church or ministry name in the title of the attachment and subject line of the email. For example: [church name]. Faith Formation Resource Grant 2025

Submissions must be received by June 30.

Review and Selection

Applications will be reviewed by the Resource Team based on the following criteria:

- 3. Innovation and creativity in faith formation.
- 4. Potential for impact and adaptability.
- 5. Feasibility and sustainability of the project.
- 6. Priority given to less financially able churches or ministries.

Grant recipients will be notified by August 1.

Reporting Requirements

Grant recipients should:

Submit a brief final report (one paragraph) after project completion, including:

- · Summary of outcomes.
- · Evaluation of impact.
- · Photos of the project.

Note: Failure to comply with reporting requirements may impact eligibility for future grants.

We look forward to partnering with you in creating new programs and ministries that inspire faith and discipleship within the Presbytery of Arkansas.

Since 2022, the Presbytery of Arkansas has provided a \$7,500 annual contribution to the Synod Partnership for Disaster Recovery. Thank you for your generous support and engagement in this partnership as together we seek to serve Christ by connecting, equipping, and empowering communities adversely affected by crises and catastrophic events across Arkansas, Louisiana,

Oklahoma, Texas and beyond.

As we enter the final year of the SPDR pilot program, we are asking each presbytery to consider the following:

- Will you renew the SPDR Covenant for an additional five years (2026-2030)?
- Will you continue providing \$7,500 annually in support of SPDR through 2030?
- Will you consider increasing your presbytery's annual gift to SPDR? If you increase your annual support beyond \$7,500, the Synod of the Sun will provide matching funds to SPDR up to \$20,000 per year over the next five years.

If your presbytery's Council would like to hear more about the impact of SPDR, please reach out to Rev. Richard Williams to schedule a time with the SPDR Leadership Group. We request that your decision regarding the SPDR Covenant renewal and funding be made by August 1st.

COVENANT BETWEEN FERNCLIFF CAMP AND CONFERENCE CENTER AND THE PRESBYTERY OF ARKANSAS APPENDIX B

(revised May 2025)

Nature of the Covenant

The covenant is a traditional document honored by people of faith. It represents a continuing agreement between Ferncliff and the Presbytery of Arkansas to affirm and support one another as distinct entities yoked in mutual mission. This covenant articulates commitments from and to each organization and seeks to perpetuate the good relations currently enjoyed. It is the hope of both parties that this document of faith will serve to bring even greater effectiveness and esteem to a positive and growing relationship.

Agencies in the Covenant

The agencies involved in this covenant agreement are the Presbytery of Arkansas PC(USA) and Ferncliff Camp and Conference Center represented by the Ferncliff Board of Directors.

Mission of the Agencies

The mission of the Presbytery of Arkansas is "The Presbytery of Arkansas inspires and connects congregations and their leaders, equips people of every generation to hear and respond to God's call in Jesus Christ, and fosters innovative expressions of ministry in response to the needs of a changing world".

The mission of Ferncliff is "As an expression of God's love, we welcome people into a life of caring for Creation, others and themselves."

History of the Relationship

In 1937 Ferncliff was purchased by a group of Presbyterians 'for the use and benefit of the Presbyterian Church in Arkansas.' Through the years Ferncliff has gradually developed into a camp and conference facility of service to Presbyterians in ministry and mission. With 1,209 acres, Ferncliff is one of the largest sites among the denomination's camps in the US. In 1976 Presbytery voted to transfer title to the Presbyterian Foundation of Arkansas. In 2023 a long-term lease (100 years) was renewed with the Foundation and Ferncliff's Board.

Governance

The reorganized Ferncliff Board of <u>Directors</u>, a 501(c)3 non-profit, had their first meeting in 1985. Ferncliff's Board normally has 18 members in three classes. The Board elects its members, paying attention to diversity and representation, and with an eye to bringing together the gifts and talents to effectively manage such a significant asset and diverse program. New members are elected in concurrence with the Presbytery of Arkansas via an annual consent agenda at a Presbytery meeting. At least one member of the Ferncliff Board shall also be serving concurrently as a member of the Board of the Presbyterian Foundation of Arkansas that holds title to the Ferncliff property. The General Presbyter is an ex officio member with vote. Ferncliff's minutes are sent to the General Presbyter who shares them with the Coordinating Team.

Commitments to One Another In order to nourish this covenant, there is a mutual commitment to active and open communication.

Presbytery's Commitment to Ferncliff

- 1. The Presbytery understands that Ferncliff, like virtually all Presbyterian camps and conference centers, needs the financial support of the Presbytery, its churches and laypersons. Facilities, staffing and programs at Ferncliff will be considered among the priorities in the Presbytery annual budget, with appropriate lead time given if there are any significant changes with their annual budget.
- 2. The Presbytery and its professional staff will actively encourage and promote the use of Ferncliff by its churches, committees, adults and youth. In selecting locations for camps, conferences, retreats and meetings, the Presbytery will look to give preference to Ferncliff while maintaining the need for responsible financial stewardship and constituency concerns. This covenant document will be shared with new ministers and Christian Educators in their orientation to the Presbytery.
- 3. The Presbytery commits itself to prayer and spiritual support for the staff and programs of Ferncliff.
- 4. While Ferncliff is a host site for events, it is also a valued partner in mission and the Presbytery commits itself to considering Ferncliff in strategic plans and visioning.

Ferncliff's Commitment to the Presbytery

- 1. Ferncliff commits to viewing the Presbytery (its churches, committees, laypeople, educators, ministers) as a critical constituency. In scheduling facilities, setting rates and selecting programs, Ferncliff will look to give preference to Presbyterians while balancing the need for financial sustainability, ecumenical relations and mission opportunities.
- 2. Ferncliff will seek to be a good steward of those material and natural resources entrusted to it. It will aim to be transparent in disclosing its finances and all decisions with regular reports to Presbytery and minutes available on request.

- 3. Ferncliff will work collaboratively with Presbytery, committees, staff and church professionals. Among services presently offered are one free weekend or two free nights annually to all ministers and Christian Education professionals for rest and relaxation; a pool of scholarship funds for campers needing financial assistance; a reduced rate to congregations of the presbytery, and to the presbytery and its committees; complimentary rooms for Presbyterians needing short term respite accommodations or attending to family members in hospitals, when space is available.
- 4. Ferncliff will work to honor the denominational commitment to issues such as diversity, inclusiveness, peacemaking, sound ecological principles and social justice.
- 5. Ferncliff is committed to connectionism among other camps and conference centers. It will continue as an active participant in the Presbyterian Camp and Conference Center Association (PCCCA) and will meet the accreditation standards of the American Camp Association

Schedule for Reviewing the Covenant

The Presbytery of Arkansas General Presbyter and Stated Clerk will meet with and the Ferncliff Executive Director and at least one of their Board of Directors no less often than every five years to review this covenant and make recommendations concerning the reformation of the covenant relationship. Additional members of both organizations are also welcome to participate in these covenant reviews.

Administrative Commission Report First Presbyterian Little Rock

January 10, 2025

The Administrative Commission for First Presbyterian Little Rock was initiated in September of 2016. Since that time the AC has worked with, supported, and been available to the session and pastor. As our previous reports have described, First LR has been through a lot over these years. It took several plus years for the congregation to work through the types of concerns that caused the AC to be formed, including significant interpersonal divisions within the congregation, which over time have been resolved. The impact of Covid hit First LR as it did every congregation, but the impact on worship attendance was important and continues to be a real concern.

The congregation had been wrestling with financial reporting and its spending habits since the inception of the AC. John Giessmann, a member and recent session member has undertaken to handle the congregation's finances and issue regular reports on the same, which is a long needed and extremely beneficial service being rendered. At this time the congregation is breaking even financially.

Stephen Moody continues as the pastor, and transitioned to a part time basis in 2023 in view of the financial condition of the congregation. Over the years Stephen, who also is quite experienced in construction, which he now pursues part time also, has spent countless hours restoring and updating various aspects of some of the primary spaces being used.

During the 2022-2023 time period, as they considered the situation of the congregation, the session had the benefit of engaging with Paul Grier and Joseph Moore of the Presbyterian Foundation, who are gifted and experienced in working with congregations on assessing their possible futures and faithful responses.

In 2024 the Stewpot ministry made a transition to a new location. First LR was the location for the Stewpot for almost 50 years, with a ministry of feeding whoever came for food at lunch during the work week. Stewpot is now at the Salvation Army location in downtown Little Rock, with bigger and better facilities and a good relationship with the Salvation Army.

The 1001 worshipping community, First Church, continues to have Sunday worship services at the congregation.

The session now has six members, and meets after worship on the second Sunday of each month. While attendance has not been what is wanted, the congregation now is a harmonious group who are continuing to worship and have some activities, even with the challenges faced by every congregation regarding how to attract and engage new members.

First LR is an historic congregation and facility. It was formed in 1828, meaning that it will be 200 years old in 2028. Its sanctuary and accompanying facilities were built in 1921, and the additional education building completed in 1957. The adjoining parking area is part of the one-half of a city block owned by the congregation. The work by Stephen Moody on these facilities as well as the handling of some insurance issues by him have been important and helpful. At the same time, the large facilities and their nature present continuing challenges regarding maintenance, insurance costs, and related considerations.

The AC believes that it has fulfilled its role and no longer is needed as an AC. The AC members would be available for information and consultation, and over the last year or so have assumed that posture with Stephen and the session, letting them know that we wish to be supportive in any way that we can.

While aware that First LR is not at all alone in continuing to try to maintain and grow as a congregation, with the ongoing responsibility for significant facilities, we believe that the Presbytery needs to continue to have in mind and be aware of this challenging dynamic which now is playing out in downtown Little Rock.

Our original group included David Dyer and Debbie Freeman as well as those remaining, Ruth Hamilton, Mike Szabo, Bill Bailey, and me. Stewart Smith was involved throughout this time, serving as Moderator of the session of First Little Rock for most of the years, which was an important contribution.

A Covenant of Pastoral Relationship

Rev. Randy Hyde and Presbyterian Kirk in the Pines, Hot Springs Village, AR

- 1. This agreement is by and between Rev. Randy Hyde and the Session of the Presbyterian Kirk in the Pines, the terms of which are subject to the approval of the Committee on Ministry of the Presbytery of Arkansas. It establishes a temporary pastoral relationship between the two parties subject to the requirements of G-2.0504(b) of the Book of Church Order of the PCUSA and commences on June 1st, 2024.
- 2. The designated title for the positions shall be "Transitional Pastor," and the terms of service shall be for twelve months, renewable upon the mutual consent of both parties and subject to the approval of the presbytery. Either party may terminate the agreement for any reason upon thirty days' written notice to the other party.
- 3. Rev. Hyde agrees to perform various duties typical of a pastor serving the needs of a congregation, the weekly hours of which are not to exceed 24 hours, as follows:
 - preparing for and leading worship, including funeral and special services;
 - visiting the sick and providing pastoral care for the congregation;
 - leading 2 or 3 short Christian Education studies during the year;
 - participating in fellowship programs to the extent possible;
 - facilitating the Session in planning and executing a Mission Study;
 - moderating meetings of the Session and of the congregation;
 - serving as a resource for various committees;
 - supervising the church staff.

Randy Hyde and the Presbyterian Kirk in the Pines whereby he serves as Transitional Pastor for the Kirk be extended until such time as the Kirk can secure a permanent pastor, unless the parties to this Covenant mutually decide to terminate the relationship at some earlier time.

Motion: that the Presbyterian Kirk in the Pines will increase Rev. Hyde's Salary and Housing during this extension by 3.5%. All other terms and conditions of the original Covenant will remain unchanged.

Extension: "A Covenant of Pastoral Relationship between Rev. Randy Hyde and Presbyterian Kirk in the Pines, Hot Springs Village, AR"

The parties to the above-mentioned Covenant Relationship for a "Transitional Pastor" have found it to be mutually beneficial as they work cooperatively during the absence of a full-time pastor at the Kirk in the Pines Presbyterian Church and desire to continue that relationship until a replacement Pastor is available. Either party may terminate this agreement for any reason upon thirty days' written notice to the other party.

All terms of the original agreement commencing on June 1, 2024, are applicable for the extension period with the exception that Rev. Hyde will be given a 3.5% Salary and Housing increase for the extension period.

Report from Youth, Young Adult, and College Ministry Moderator MWS Margaret Alsup

College Ministry Updates:

Lyon College—With the support of the presbytery we were able to host our Sabbath Scholars Retreat this spring. It was a time to gather and practice sabbath. It is the second year we have hosted this retreat and received support from the presbytery. Students are grateful to the presbytery for helping fund this much needed program and retreat. We also received funds to help with our food pantry that continues to serve and expand services for our students. Due to the current economy and cost of college, the pantry has been visited more and we are serving a larger population than our previous year. We were disappointed we were unable to host the presbytery this spring, but we look forward to doing so in the future.

United Campus Ministry— This spring, United Campus Ministry launched seven graduates and one transfer student into the world. While a few students are still finalizing their post-graduation plans, we have students pursuing graduate school, seminary, military service, human services, corporate work, environmental science, nursing, and journalism. This semester we participated in worship leadership in Fayetteville and Bella Vista. We participated in student led evening prayer and had student-initiated gatherings at a local restaurant patio. We had eight students participate in our spring fundraiser where we pivoted the activity to hiking, something these students enjoy more than biking. This fundraiser is critical to our planning for wonderful opportunities in the fall and we continue to encourage participation through June.

University of the Ozarks— Spiritual Life at U of O continues to provide faith formation opportunities for students in a myriad of ways. A few highlights of the year were: The launch of a two year, grant-funded internship program for students to cultivate leadership in church communities. This year, 3 students participated serving two different local congregations (a Methodist and a non-denominational) to see how each church functions as a church and how they engage the local community. Students were able to serve both congregations to compare and contrast leadership style and approaches both practically and theologically and discern where each student's sense of call may be in serving the Church. Second, thanks to financial support from the Presbytery of Arkansas and a grant from the Synod of the Sun, 13 students were able to travel during spring break to El Paso, Texas and Cuidad Juarez, Mexico for a border encounter. Students learning the history, political, and local dynamics of the border along with engaging with migrants at a shelter in Juarez. Throughout the week, students were overwhelmed by the commitment of the Churches in Juarez caring for migrants, found personal connections to their own stories, and discerned ways to help share the stories from the border with those in their own communities. Third, the U of O was thrilled to host Presbyterian Pastor and current Chaplain for the United States House of Representatives the Rev. Dr. Margaret Kibben for our annual Farmer Lecture. We continue to look for pastors to participate in our Struthers Pastoral Study Leave program - an all-expense paid week of self-guided study leave on campus. We are looking for applicants to come in the fall of 2025, applications are due by June 30. You can contact Chaplain Jeremy Wilhelmi for an application and more information. Lastly, the campus continues to have a thriving weekly chapel service on Tuesdays, offers various spiritual engagements both on and off campus, and provides pastoral care to the campus community.

Youth Trips & Events from the Spring

Mission: Possible— April 4th-6th, Youth from the Presbytery joined together for Mission: Possible, where they participated in hands-on service, play, worship, singing and learning about ministries around Northwest Arkansas. The youth began the weekend with games and devotions led by adult leaders Katie Flood, Grace Blazer, and

Drew Parker. The group woke up early on Saturday morning to serve alongside others at FPC Bentonville's food pantry ministry, a weekly food pantry which serves families throughout the area. The group was then hosted by FPC Rogers for a delicious lunch, songs, and games, where they learned from Rev. John Arnold about all of the ways Rogers serves people in the region - such as holding luggage and food drives and leading GriefShare programs. The youth then piled in the van to travel to Mt. Comfort Presbyterian Church, a historic gem in our Presbytery. They shelled okra pods, and learned all about their composting system and extensive garden ministry which feeds folks in our area. After learning from the folks at Mt. Comfort, the group traveled to FPC Springdale, where we enjoyed an incredible meal and listened as Pastor Jesse told us all about Ministerio a la Vecindad, a Hispanic ministry at FPC Springdale. We ended the evening playing at the retro arcade. On Sunday morning, the group traveled north, where they joined folks at the Presbyterian Church of Bella Vista for an amazing breakfast, and worship. Thank you to all of the congregations who hosted the group over the weekend and for the adult leaders who guided the group through hands-on service, play, worship, and education. The hospitality of the churches in this Presbytery never ceases to amaze me! Thanks be to God for the ways our churches serve God and neighbor in myriad ways.

Confirmation Retreat—We had a great time at the Presbytery Confirmation Retreat February 28-March 5. Nine youth came together to pray and learn together. From playing horseshoes to making s'mores to tackling a "church problem" in a mock Session format, the weekend was full of insightful, thoughtful discussions and asking big questions about faith. Thanks to Drew, Kristi, Jared, and Sarah for leading. A big thank you to the generosity of Ferncliff Camp and Conference Center for partnering with us to make this retreat happen.

Informational Items

Financial Review

Summary

Overall, the Presbytery's finances continue to be in good condition, primarily due to earnings on investments and cash, and maintaining spending within budgets. However, the volatility of the markets and the effect on investments, the reduced Mission Acceptance from congregations in the Presbytery, and the additional spending that will be required under the long-range plan must continue to be monitored.

Revenues and Expenditures

Through March 31, 2025, year-to-date net revenue was -\$1,725. Excluding \$42,000 of budgeted line items that have not yet been funded (primarily camps & conferences), year-to-date expenditures were about \$9,000 less than budgeted. Revenues were about \$5,000 less than budgeted, primarily Mission Acceptances, many of which are paid annually.

Investments

2025 has been very volatile, primarily due to uncertainty surrounding trade tariffs. The 36-month rolling average on the spend rate helps in leveling out the high and low months.

Mission Acceptance / Benevolence (Congregational Giving to Presbytery)

The decline in Mission Acceptance is an ongoing concern of the CoA.

The following chart shows the reduction in Mission acceptance year-over-year. Note that while the budgeted amount has decreased each year, the actual receipts have declined even more than the budget projections.

Audit

The audit of the Presbytery's financials by Landmark CPAs is ongoing and is expected to be completed in June 2025.

CoA Meeting Actions

April 8, 2025 – Scheduled Meeting

The committee discussed an unsecured emergency loan to a pastor for which a notice of a Chapter 13 bankruptcy was received. Due to the small loan amount and the cost of attorney representation, the committee decided to file a claim but not engage an attorney to represent the Presbytery.

The committee approved a motion to recommend that the Coordinating Team renew the Presbytery's five-year pledge of \$7,500 per year to the Synod of the Sun Partnership for Disaster Recovery, and to increase the pledge to \$8,500 per year.

The committee discussed the renewal of the Ministry Architects' contract to implement the 2024 strategic plan. Funds are available if the contract is renewed. The committee decided to refer the matter of renewing the contract to the Coordinating Team.

May 12, 2025 – Called Meeting

The Moderator called a meeting of CoA on May 12 to discuss deficit spending related to a 1001 New Worshiping Communities congregation. After a lengthy discussion of the issues that led to the deficit, the committee tabled the matter until additional information could be reviewed. The Moderator will request the information from the host church, then schedule a follow-up meeting.

As part of the discussion, the CoA began investigating the Presbytery's policies and processes for matching grants to the 1001 New Worshiping Communities. This is an ongoing process.

Presbyterian to English Cheat Sheet

From time to time abbreviations and acronyms will be peppered through the meeting. The following is a quick primer on Presby-speak. If you have questions about any of these terms or the way they fit into the larger picture of the life of the church, feel free to ask the Stated Clerk!

- AC- An Administrative Commission is a group of Ministers of the Word and Sacrament and Ruling Elders given specific responsibilities and authority to act on behalf of the presbytery between meetings. They are typically formed to ordain and/or install pastors, perform the tasks associated with dismissing, closing, or merging congregations, deal with difficulties in a particular church, or assist a church in times of transition.
- **Board of Pensions-** The General Assembly agency charged with overseeing the benefits plans for pastors and some other church employees.
- *Candidate-* A person in the latter portion of the ordination process for the ministry of Minister of the Word and Sacrament.
- *CRE* A Commissioned Ruling Elder is an ordained elder in good standing in his/her member church and is commissioned to serve in a congregation or validated ministry of the presbytery.
- COM- The Committee on Ministry provides oversight and advocacy for congregations and Ministers of the Word and Sacrament. It receives Ministers of the Word and Sacrament from other presbyteries, approves calls for pastoral services, oversees congregations without pastors, dissolves pastoral relationships, dismisses Ministers of the Word and Sacrament to other presbyteries, determines of the criteria for validating ministries of non-parish clergy, and oversees Commissioned Ruling Elders serving congregations.
- **CPM-** The <u>Committee on <u>Preparation</u> for <u>Ministry oversees the process of preparation for the ministry of Ministers of Word and Sacrament, training of Commissioned Ruling Elders, and the process of certification for Christian Educators.</u></u>
- *Council* In the context of Presbyterian polity and governance, a council is a governing body of the church. The councils of the PC(USA) are the session, the presbytery, the synod and the General Assembly.
- *CT* The <u>Coordinating Team of the presbytery acts on the presbytery's behalf on routine matters between stated meetings, coordinates the ministries of the presbytery, and plans for presbytery meetings.</u>
- **GA-** The <u>General Assembly of the PC(USA)</u> is the highest council of the church. It meets in even numbered years for a week. The 2020 meeting will be held June 16-23 in Baltimore, Maryland.
- *HR* <u>H</u>onorably <u>R</u>etired is a designation for Ministers of the Word and Sacrament retired from active service to the church who remain in good standing with the PC(USA).
- *Inquirer* A person in the initial phase of the process of preparation for ministry as a Minister of Word and Sacrament.
- *MIF* A <u>Ministry Information Form is the standardized format for advertising certain church professional positions through the PC(USA) Church Leadership Connection.</u>
- *MWS* <u>M</u>inister of the <u>W</u>ord and <u>Sacrament is an ordained Presbyterian minister member of the clergy, formerly called a <u>Teaching Elder.</u></u>
- *Moderator* The Moderator is the person elected to keep order and chair the meetings of the presbytery. The pastor or CRE of a local congregation serves as the moderator of the local session.
- *NCD* New Church Developments are new ministries of the presbytery engaged in a formal process to work toward establishing a new congregation.
- **PDA-** Presbyterian Disaster Assistance is an agency of the Presbyterian Church (USA) Mission Agency. PDA assists communities coping with natural and human-caused disasters.

- *PJC* Permanent Judicial Commission implements the disciplinary procedures required by the *Book of Order*. There is a Judicial Process Manual which gives details on these duties.
- **PMA-** The <u>Presbyterian Mission Agency is part of the larger PC(USA) and is located at national church headquarters in Louisville, KY.</u>
- *PNC* <u>Pastor Nominating Committee is a search committee elected by a congregation to seek, interview, and recommend a new pastor.</u>
- **RE/Ruling Elder-** Ruling Elder is a lay member of a congregation who has been elected, ordained and installed to serve on the session of a church. Ruling elders are eligible for election as commissioners to presbytery, synod and General Assembly. Once ordained as a ruling elder one maintains that office whether serving on a session or not.
- **Stated Clerk** Stated Clerk is the officer elected by the presbytery to maintain the official records, provide extracts when asked, prepare the docket for presbytery meetings, and answer questions about the records, Presbyterian polity, policies, procedures and history. The Stated Clerk is authorized to certify ministers and congregations are in good standing and qualify under the tax exemption of the PC(USA).
- **Synod of the Sun-** The governing body council which includes all the presbyteries in Texas, Oklahoma, Arkansas and Louisiana. It coordinates the work of the PC(USA) in this region.
- *TPF* <u>Texas Presbyterian Foundation is a financial service organization for Presbyterian members, councils and institutions. It invests funds and provides bookkeeping services for Arkansas Presbytery.</u>
- *Validated Ministries* Positions served by chaplains, professors and other Ministers of the Word and Sacrament who are not currently serving a congregation. Sometimes they are referred to as non-parish clergy.

Tips for Commissioners on Procedure and Parliamentary Practice

Parliamentary procedure enables the presbytery to become a deliberative assembly, to seek the will of God and to witness to our faith in Jesus Christ. It is never an end in itself. Parliamentary gamesmanship is never appropriate. The will of the majority shall prevail, but the rights of the minority shall always be protected. Parliamentary principles balance individual conscience with the will of the majority. It takes seriously the following rights of individual members:

- (1) the right to know (due notice)
- (2) the right to speak (rules of debate)
- (3) the right to vote (membership)
- (4) the right to hold office (fair representation)

The Moderator represents the unity of the body. The Moderator preserves decorum and protects the rights listed above.

Parliamentary procedure allows discussion of a subject only when a motion about that subject has been made. To speak during the meeting, first go to a microphone. When recognized by the Moderator, state your name, church, city and status – such as Minister of the Word and Sacrament, Ruling Elder, or Honorably Retired. You may speak to a pending motion or ask a question. The person making the motion will have the first opportunity to speak to the motion. Only motions coming from individuals need a second. A motion made on behalf of a ministry area or a committee already has a second because it is the majority vote of the committee.

Ordinarily, only commissioners may speak and vote on motions (Minister of Word and Sacrament members of the Presbytery; Ruling Elders elected by their Session; Ruling Elders elected as General Presbyter, Stated Clerk, Assistant Stated Clerk, Treasurer, Moderator, or Moderator-in-Waiting (Vice Moderator); Commissioned Ruling Elders in current service; members of the Coordinating Team; current commissioners to General Assembly; and Ruling Elders who are Certified Christian Educators).

At the Spring meeting of the Presbytery Youth Advisory Delegates and Young Adult Advisory Delegates have "privilege of the floor," meaning that they have permission to speak to motions, and they take an advisory vote prior to the vote by commissioners. At any meeting someone in attendance may be given privilege of the floor, allowing that person to speak to the body, which is ordinarily given near the beginning of the meeting. Privilege of the floor does not mean that person may vote.

It is advisable to speak only once on a subject, but you may seek to speak a second time only after everyone who wishes to speak has spoken. All remarks during debate shall be addressed to the Moderator. Questions seeking information from a person who has the floor shall be addressed to the Moderator. Speeches to an individual or the whole presbytery are not permitted during debate. Reading reports or documents out loud requires the permission of the body. In debate, remarks shall be confined to the pending motion. Remarks shall not impugn another commissioner or that person's motives. Commissioners' names shall not be used.

To end debate, a commissioner must go to a microphone and, when recognized by the Moderator, state: "I move the previous question." It is not appropriate to call the question without going to a microphone. If you offer a substitute motion or a new item of business, you should give the Moderator and Stated Clerk

advance notice and written copy. An electronic copy is preferred – using Microsoft Word on a memory stick or thumb drive. Not only will this help these officers facilitate the work of presbytery, they may also be able to help you with suggestions as to how and when it would be appropriate to make the motion. The Stated Clerk and the Moderator are available to advise commissioners on the wording of any motion so that it can clearly express the concerns of the commissioner. When in doubt, ask. The Moderator and the Stated Clerk are eager to help you understand and use the process.

Commissioners should always read all information provided in the packets and subsequent information provided at the registration table. Whenever possible questions concerning reports or motions should be directed to the Moderator of a ministry area or committee making the report or motion prior to the meeting. Contact info on moderators may be obtained through the presbytery office. Often concerns may be cleared up prior to a meeting rather than on the floor of presbytery.
